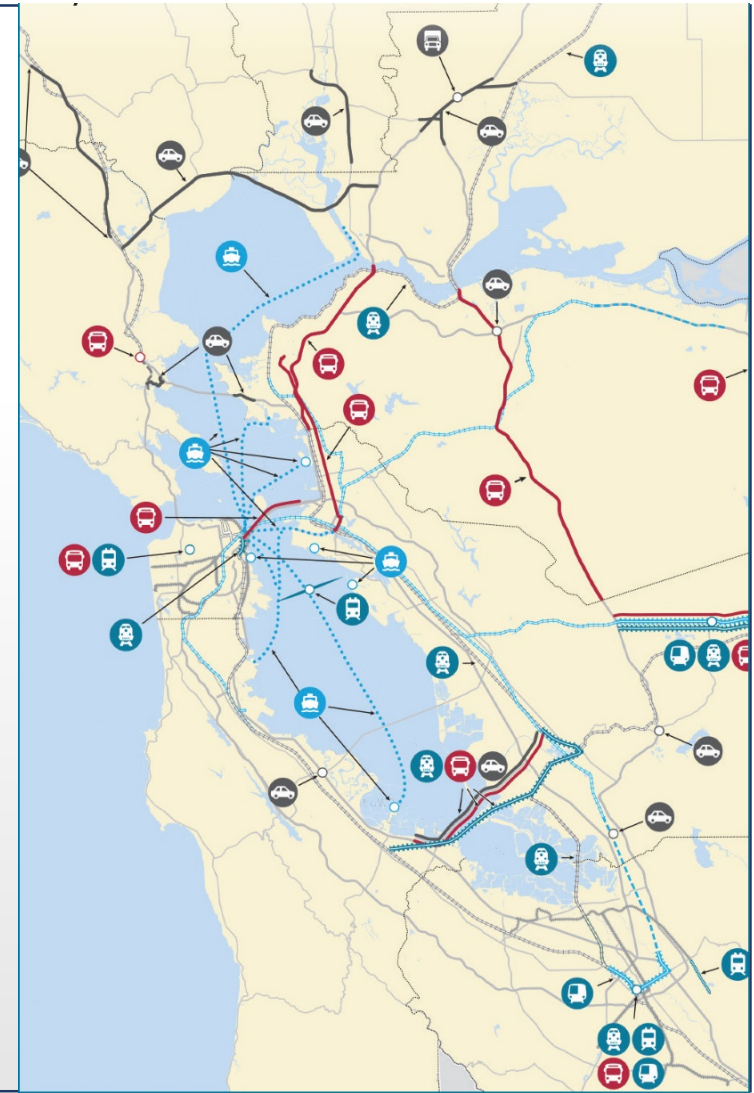

Regional Measure 3 Approved Toll Increase

- Voters in the nine-county Bay Area approved RM3 on the June 5, 2018 ballot.
- Funds transportation projects to relieve traffic and enhance public transit options.
- Schedule of toll increases:
 - January 1, 2019 (\$1)
 - January 1, 2022 (\$1)
 - January 1, 2025 (\$1)

Carpool Discount

- Rate is 50% of the standard toll (5am-10am, 3pm-7pm)
- The carpool rate will increase by \$0.50 every 3 years

Multiple Bridge Commuter Discount

- Drivers paying 2 peak period tolls in one day receive discount on 2nd toll
 - \$0.50 for a full fare, \$0.25 cents for a carpool (Refunded by RCSC)
- Requirements:
 - Bay Area FasTrak® account holders with two axle vehicles
 - Must use same toll tag or license plate for both trips
 - Maximum of 2 discounts per calendar day per toll tag or vehicle

Common Examples How the Multiple Bridge Discount Would Work			
	Jan. 1, 2019- Dec 31, 2021	Jan 1, 2022- Dec 31, 2024	Jan 1, 2025
2 Trips (2 Axle)	\$11.50 (Regular: \$12)	\$13.00 (Regular: \$14)	\$14.50 (Regular: \$16)
2 Trips (Carpool)	\$2.75 (Regular: \$3)	\$3.00 (Regular: \$3.50)	\$3.25 (Regular: \$4)

Pending Litigation

- Two lawsuits filed against MTC
- RM 3 tolls placed in escrow account starting January 1, 2019
- Daily transfer of RM 3 funds from BATA to a Union Bank trust account
- Allocations for operating or capital programs cannot occur while funds in escrow
