Purchase Order for Internal 6C FasTrak® Toll Tags: TransCore LP (\$9,803,000)

Subject:

A request to issue a purchase order in an amount not to exceed \$9,803,000 to TransCore LP to purchase 1,236,000 internal FasTrak® 6C toll tags for FY2019-20, subject to the approval of the FY2019-20 BATA budget.

Background:

In a recently approved state regulation (California Code of Regulations, Division 2, Title 21, Chapter 16), all tolling agencies in California are required to transition from the current Title 21 toll tag protocol to the new 6C toll tag protocol. To comply with the new regulation, BATA issued a Request for Qualifications (RFQ) in October 2018 to establish a bench of pre-qualified vendors to provide up to 2,340,000 6C toll tags through June 30, 2021 and to select vendor(s) to provide the first year's quantity of tags. In January 2019, staff presented the results of this RFQ to this Committee which referred the matter to the full Authority. The Committee also expressed the desire for a California-based vendor preference policy to be adopted for future purchases of tags. Staff has committed to develop and implement a California-based vendor preference purchasing policy within approximately a year. BATA subsequently approved the bench and purchase orders for the first year's quantity of tags at its January meeting. Following receipt of a protest, BATA canceled the RFQ and issued another procurement.

An Invitation for Bid (IFB) was issued on March 6, 2019 for 1,236,000 internal tags (996,000 non-retail tags and 240,000 retail tags) and 15,000 external tags. Under the IFB bidders were invited to submit separate bids for the internal tags and the external tags. The IFB provided that contract(s), if awarded, would be to the responsible bidder(s) that submit the lowest bids for internal tags and for external tags. This procurement was expected to provide sufficient 6C toll tags for twelve months, at which time a new procurement will be in place for further toll tags. Staff received two responsive bids for internal 6C tags by the deadline of April 25, 2019 from Kapsch TrafficCom USA, Inc. and TransCore LP. Staff did not receive any responsive bids for external 6C tags. The bid prices received are referenced in Attachment A.

The lowest total bid submitted for internal tags is from TransCore LP. TransCore LP is neither a small business nor disadvantaged business enterprise and currently have no subcontractors.

Recommendation:

Staff recommends that the Committee authorize the Executive Director or designee to issue a purchase order to TransCore LP in an amount not to exceed \$9,803,000 to purchase 1,236,000 internal 6C FasTrak® toll tags for FY 2019-20, subject to the approval of the FY 2019-20 BATA budget.
