Funding Agreement - Downtown Congestion Pricing Study: San Francisco County Transportation Authority (\$400,000)

Subject:

This item would authorize a funding agreement with San Francisco County Transportation Authority (SFCTA) in an amount not to exceed \$400,000 for consultant services to conduct the Downtown Congestion Pricing Study.

Background:

SFCTA is conducting a Downtown Congestion Pricing Study to examine alternatives and develop an implementation plan for a congestion pricing program in downtown San Francisco. SFCTA has requested BATA's assistance in funding this study. Because the project may help manage travel demand, may integrate with the toll collection operations of the state-owned bridges, and is consistent with the BATA Long-Range Plan (BATA Resolution 72, Revised), staff proposes that BATA contribute Toll Bridge Program Operating funds in an amount not to exceed \$400,000. SFCTA will pay for consultant services for the study using \$700,000 of their local and federal funds. BATA staff will serve on various advisory committees that SFCTA is developing for the study. When congestion pricing is implemented, commuters using the San Francisco-Oakland Bay Bridge may benefit from reductions in delay and opportunities to shift from drive-alone into shared uses such as carpooling, vanpooling and transit.
