Contract Amendment – I-580 Richmond-San Rafael (RSR) Bridge Access Improvement Project – On-Call Design Services: HNTB Corporation (\$806,000)

**Subject:** 

This item would authorize a contract amendment with HNTB Corporation (HNTB) for on-call design services in an amount not to exceed \$806,000. These additional services are required for the completion of the I-580 Richmond-San Rafael Bridge Access Improvement Project (the Project).

**Background:** 

The construction of a bicycle-pedestrian path and the completion of additional improvements associated with the new peak period use lane (PPUL) in the eastbound direction of the Richmond-San Rafael Bridge are underway. This project reduced traffic congestion in the eastbound direction of I-580 across the bridge by converting the shoulder to a PPUL, which opened last April. The project will also convert the shoulder in the westbound direction into a bi-directional bicycle-pedestrian path that is separated from motor vehicles by a moveable concrete barrier system.

The Project's objective is to reduce congestion and travel time on eastbound I-580, including the Richmond-San Rafael (RSR) Bridge by providing a third eastbound peak period use lane (PPUL) during the afternoon peak travel period. The Project will also improve pedestrian and bicycle travel adjacent to the I-580 corridor by constructing a barrier-separated path connection from the Tewksberry/Standard Avenue Intersection near Point Richmond to Stenmark Drive near Point Molate.

Contractor Selection Process: In January 2014, after a competitive procurement, the BATA Oversight Committee approved a pool of eight firms, including HNTB, to provide on-call design services for a two-year period with an option to extend. Based on the recommendation by a review panel comprised of staff members from BATA, Caltrans and the Transportation Authority of Marin, the Committee authorized a contract with HNTB on March 5, 2014 for design of the Project.

Summary: This amendment allows for the completion of the work that started under the January 2014 competitive procurement. Specifically the amendment allows for the completion of both active construction contracts (Package A –RSR Bridge Peak Period Use Lane and Package B1 – RSR Bridge Bicycle-pedestrian path). This amendment also provides additional funds to complete design services that are required to complete the design and provide for the improvements along Francisco Boulevard in the City of San Rafael that are already underway. The ultimate improvements were separated out from the Package B1 improvements due to property right acquisition delays. When advertised, the ultimate Francisco Boulevard Improvements will be construction as Contract B2.

The majority of this increased effort is in two increased scope items. The first is additional design services during construction due to the longer than anticipated construction duration. The second is additional construction change order design work to eliminate a gap in the sidewalk along Francisco Boulevard to provide a temporary pedestrian connection from the RSR Bridge to the existing sidewalk on Francisco Boulevard in the next three months. The ultimate B2 construction package also needs to be updated to reflect the change order work and associated staging.

Attachment A includes a summary of HNTB and its project team's small business and disadvantaged business enterprise status.

**Recommendation:** 

Staff recommends that this Committee authorize the Executive Director or designee to negotiate and enter into a contract amendment with HNTB in an amount not to exceed \$806,000 to provide design services for the completion of the Project.
