ENERGY PROGRAM MANAGER'S REPORT

Jenny Berg provided updates on the Energy Group's recent introductory meeting with Therese McMillan, MTC's Executive Director, and the approval of the Association of Bay Area Governments' FY 2019-20 Budget and Work Program at its General Assembly on June 6.

In addition, she noted the preparation of a regulatory filing requesting calendar year 2020 budget approval for the Bay Area Regional Energy Network (BayREN).

REPORT ON NATURAL GAS PROGRAM

Monthly Summary of Operations FY 2018-19

Ryan Jacoby provided members with a Monthly Summary of Operations for FY 2018-19. Members were updated on the percentage savings comparisons with PG&E, noting that financial statements through April, 2019 indicated a cumulative savings figure of –9.7%.

He noted the distribution of three articles regarding U.S. Natural Gas Storage Inventory, Renewable Natural Gas efforts at SoCalGas, and Hawaii's On-Bill Financing Program, GEM\$.

Gas Hedge Chart

Ryan Jacoby presented an analysis on the program's current gas purchasing strategy-short-term markets within California, Oregon, and Alberta, Canada.

Market Price Chart

Ryan Jacoby provided information on current and historical gas prices, highlighting significant price volatility this winter and a relative decline in market prices beginning in April 2019.

FISCAL YEAR 2019-20 OPERATING BUDGET

May Yin presented the Committee with an Operating Budget for Fiscal Year 2019-20, indicating a 2% increase, from \$7.6M in FY 2018-19 to \$7.8 million, primarily due to an increase in PG&E's pass-through costs.

Ryan Jacoby reviewed the calculation of program participants' monthly levelized charges, and noted that members' Working Capital Deposits remain unchanged from FY 2018-19 (\$2,000,785), representing approximately three months of working capital and exceeding the program's stated goal of at least two months. Therefore, no additional deposits are anticipated during Fiscal year 2019-20.

Motion was made by Oyler/S/Walton/C/5:0:0 to deem the Working Capital Deposits sufficient and approve as proposed the Fiscal Year 2019-20 Operating Budget and associated levelized charges, totaling approximately \$7.8 million.

RENEWABLE NATURAL GAS & RELATED OPPORTUNITIES
