Contract Amendment – Open Road Tolling System Technical Support: Silicon Transportation Consultants, LLC (\$200,000)

## **Subject:**

This item requests Committee approval to enter into a contract amendment with Silicon Transportation Consultants, LLC (STC) to provide technical support and expertise to the Bay Area Toll Authority (BATA) while a new Open Road Tolling System (ORT) is being designed and implemented as part of BATA's conversion of the seven state-owned toll bridges to All-Electronic Tolling (AET), subject to the approval of future BATA budgets.

### **Background:**

In December 2018, the BATA Oversight Committee approved staff's recommendation for a schedule to convert the seven existing toll plazas to ORT. Among the projects required to achieve this objective includes replacement of the current BATA tolling system, known as the Advanced Toll Collection Accounting System (ATCAS), with a new toll collection and accounting system. ATCAS is comprised of lane equipment that detects vehicles and toll tags, cash collection equipment, a financial reporting system, and servers and hosts that store and exchange transaction data and information with the FasTrak® back office system.

The new tolling system would replace ATCAS in its entirety and BATA is seeking STC's support with the design and implementation of the new toll system that supports AET/ORT. STC has demonstrated it has the expertise and experience required to deliver the technical oversight and implementation support for a new toll system. STC's extensive experience with related projects made it the best programmatic fit to perform the anticipated scope of work. Tasks include analyzing and reviewing the operational requirements, defining financial and internal control requirements, developing system architecture design and overseeing the implementation, testing, and integration of the new tolling system.

#### **Contract History**

STC is a resource competitively procured under the 2016 Electronic Payments Section Consultant Assistance Bench (Bench). STC is currently under contract with BATA to provide technical assistance to support updates to California's tolling interoperability requirements and the transition from the Title 21 protocol to the 6C protocol. STC's previous experience supporting BATA Finance goals, and its insight into the project processes and stakeholders, will facilitate the conversion to AET. For this reason, BATA staff recommend a direct selection award to STC to add this scope of work to its contract. Under the provisions for assigning work outlined in the Bench procurement, award of contracts to Bench firms can take place by a direct selection or via a mini-procurement with any or all of the pre-qualified firms is allowed. Based on analysis of the level of effort necessary to complete the project requirements, BATA staff estimate the cost of the needed services at approximately \$100,000 per year, for a two-year period.

STC is a Small Business, Disadvantaged Business Enterprise and Minority Owned firm that is locally owned and operated in the San Francisco-Oakland Bay Area. Attachment A includes a summary of STC and its project team's small business and disadvantaged business enterprise status.

#### **Recommendation:**

Staff recommends the Committee authorize the Executive Director or designee to authorize a contract amendment in an amount not to exceed \$200,000 to provide technical support for the design and implementation for a new toll collection system, subject to the approval of future BATA budgets.
