Contract – I-580 Richmond-San Rafael Bridge Forward - Open Road Tolling and HOV Lane Preliminary Engineering and Environmental Planning: Kimley-Horn and Associates, Inc. (\$4,800,000)

Subject:

This item requests Committee approval to enter into a contract with Kimley-Horn and Associates, Inc. (Kimley-Horn) in an amount not to exceed \$4,800,000 to provide preliminary engineering and environmental planning services to obtain project approval for the I-580 Richmond-San Rafael Bridge - Open Road Tolling and HOV Lane Project (RSR Forward), subject to the approval of future BATA budgets.

Background:

In 2014, BATA took responsibility for funding and implementing the I-580 RSR Bridge Access Improvement Project. In the eastbound direction, the project effectively relieved traffic congestion on Eastbound I-580 and improved travel times for the afternoon commute by converting the shoulder into a Peak Period Use Lane (PPUL) that opened to traffic in April 2018. In the westbound direction, the project converted the shoulder into a bicycle-pedestrian path – closing a significant gap in the Bay Trail and providing new travel mode options across the bridge. This new path will open to bicyclists and pedestrians later this month. A newsletter that highlights many of the existing projects under development on the RSR Bridge can be found in **Attachment A**.

The RSR Forward initiative will expand on these projects with additional westbound improvements, including: 1) eliminating the existing bottleneck caused by the toll plaza by installing gantries to be used for Open Road Tolling (ORT), which will replace cash toll collection; 2) reinstating a previous westbound I-580 HOV lane through Richmond to encourage carpooling; and 3) enhancing Golden Gate Transit express services to increase transit ridership between Marin and Contra Costa Counties.

On August 6, 2019, BATA issued a Request for Qualifications (RFQ) for Preliminary Engineering and Environmental Planning Services to support the two projects described above (implementing ORT and an HOV lane). The scope of work will also include developing strategies for improving the nearby Richmond Parkway and the I-580 Richmond Parkway Interchange.

Statement of Qualifications (SOQs) were received from three engineering firms: Kimley-Horn, AECOM, and Rajjapan & Meyer. The SOQs were evaluated by a panel of BATA, Caltrans and Contra Costa Transportation Authority staff on the basis of the following evaluation criteria: qualifications of team to complete the scope of services (30%); experience in completing similar projects (30%); understanding of the project (30%); and project team availability (10%).

Since all three firms have strong experience in providing similar services, the evaluation panel chose to interview all three. Based on the results of the interviews that were held on October 3, the firms were ranked as follows:

Firm	Kimley-Horn	AECOM	Rajjapan & Meyer
Average Score	91.5	86.75	77.5

The evaluation panel determined Kimley-Horn to be the highest ranked firm based on the evaluation criteria identified in the RFQ. Kimley-Horn demonstrated a thorough understanding of the scope of work that emphasized the importance of all the requirements for project approval. Their team included key members with experience converting an existing general purpose lane to an HOV lane. If BATA and the highest ranked firm are unable to agree upon the terms and conditions of the firm's contract through negotiations, BATA reserves the right to reject the SOQ and negotiate with the next highest ranked firm and so forth until BATA and a firm agree upon the contract terms.

The preliminary engineering and environmental planning scope of work may be eligible for reimbursement from RM3 funds, subject to further Commission approvals. BATA Toll Bridge Rehabilitation Program funds may be returned by the project to BATA.

Attachment B includes a summary of Kimley-Horn and its project team's Small Business and Disadvantaged business enterprise status.

Recommendation:

Staff recommends that the Committee authorize the Executive Director or designee to negotiate and enter into a contract with Kimley-Horn to provide preliminary engineering and environmental planning services in an amount not to exceed \$4,800,000, subject to the approval of future BATA budgets; and, should staff be unable to negotiate a contract with Kimley-Horn, that the Executive Director or designee be authorized to negotiate and enter into a contract with AECOM or Rajjapan & Meyer, in that order.




ATTENTION, BAY AREA MOTORISTS!
