Dear Bay Area Toll Authority Oversight Committee Members,

As a neighbor who lives within 100 feet of a Bay Bridge onramp, I want to strongly urge you to study and pursue a buildout of a bike path on the western span of the Bay Bridge.

I frequently travel to/from the East Bay multiple times each week. In fact, proximity to the bridge is one of the reasons I choose to live near where I am. However, it's incredibly disappointing that with a bridge nearly 60 feet wide, the only option given for travel is by vehicle. And, among those vehicles, zero preference is given to mass transit — they travel at the same speed as every other vehicle.

This needs to change. I want to be able to have better options when traveling to the East Bay, and that could decrease congestion by getting me and people like me out of our cars, and onto buses, bikes, scooters and other modes.

We should not wait for additional infrastructure either. Why not take a lane of the Bay Bridge and make it a bus lane on weekdays and bike lane on weekends? We should do that, and do it tomorrow.

I am a San Francisco resident writing in support of the proposed West Span Bike Path which will come before you at BATA. Right now the Bay Bridge lacks a westbound pedestrian and bike lane. With our climate crisis poised to affect every aspect of our lives in the coming decade, we need to support cyclists the same way—if not more—the government supports car drivers.

It's bad enough that San Francisco, unable to meet its housing needs for low- and moderate-income workers, must import them from East Bay. But with BART crowded, many turn to cars for their commute. This is unacceptable, and it's one of the reasons why transportation accounts for 40% of California's carbon emissions. Cars are also enormously expensive, so requiring transbay workers to own one only exacerbates the income inequality they experience.

Bike infrastructure cannot solve all of the problems with our regional economy. But it will ease the problems many workers face, and it will allow people to commute in a more sustainable and equitable fashion. Please support the west span proposal.

My name is Charles Whitfield, and I'm a San Francisco resident and Bay Bridge user. I'm writing to urge you to support the "Bay Skyway" bike & pedestrian path on the Bay Bridge.

I don't own a car, so I get around by a combination of public transit, walking, and biking. However, my options when traveling to and from the East Bay are more limited: I have to take either public transit or an expensive taxi or rideshare. I would love to have other choices available when I travel to Oakland or Emeryville, especially to places that aren't directly served by transit.

On a broader level, I think it is critical as a matter of climate action and transportation equity to provide more infrastructure for non-car transit. Traveling by bus, bike, or foot is greener, cheaper, more space efficient, and, when protected from traffic, safer than car travel. We should encourage these modes of transportation at every opportunity.

Thanks for your work on this issue. I want to again urge you to support the Bay Skyway and to further state my strong support for any other policies that promote non-car transit, including dedicated bus lanes on the Bay Bridge.
