Contract Amendment – Express Lanes Network Highway Maintenance Services: Econolite Systems, Inc. (\$9,000,000)

Subject:

A request for approval to enter into a contract amendment with Econolite Systems, Inc. (Econolite), in an amount not to exceed \$9,000,000 through April 30, 2023 for comprehensive maintenance services, including some construction services, for express lanes highway infrastructure on BAIFA's express lanes on a scheduled and as-needed basis, subject to the approval of future BAIFA budgets.

Background:

Econolite is currently providing routine and as-needed comprehensive maintenance services for express lanes civil infrastructure and field elements of the backhaul communications network on the I-680 South Express Lanes in Contra Costa County between Walnut Creek and San Ramon. The scope includes routine preventative maintenance, corrective maintenance as needed, including emergency repairs, and spare parts for express lane infrastructure such as fiber optic cable, cabinets, signs, roadway lighting, conduit, and pull boxes.

The I-880 Express Lanes in Alameda County from Hegenberger Road to Dixon Landing Road in the southbound direction and from Dixon Landing Road to Lewelling Boulevard in the northbound direction are projected to open late Summer 2020. Additionally, the I-680 North Express Lane from Marina Vista Boulevard to Rudgear Road in the southbound direction (delivered by the Contra Costa Transportation Authority) is projected to open fall 2021.

Maintenance activities typically begin before express lanes start of tolling. Once civil construction activities are completed and approved by BAIFA and Caltrans, relief of maintenance may be granted to the Contractor for portions of a corridor or the entire corridor, thereby transferring responsibility for maintenance of express lanes infrastructure back to BAIFA. Completion of the toll system testing is not required for relief of maintenance. To ensure a seamless transition between construction and maintenance, staff recommends an express lanes segment or corridor be added to the maintenance contract once relief of maintenance is issued. Staff will be returning for Authority approval in the future for the San Mateo 101 Express Lanes Project as BAIFA will be providing maintenance services for the San Mateo County Express Lanes Joint Powers Authority on a reimbursed basis.

In addition to the maintenance services described above, Econolite may assist with any remaining express lanes construction items needed immediately prior to opening of an express lane, such as sign wrap installation and removal, signage installation, and pavement striping and markings. Econolite staff previously performed similar work prior to opening the I-680 South Express Lanes. Econolite has consistently provided excellent customer service and has proven to be knowledgeable and responsive to emergency calls, as needed repairs and routine maintenance, and as needed construction services.

Express Lanes infrastructure not maintained under this contract, such as electronic tolling equipment and backhaul communications network equipment, will be maintained through other BAIFA agreements. Caltrans will perform maintenance for items such as concrete median barriers, pavement markers and striping, storm drain clean out and sweeping under an agreement approved by BAIFA in November 2016.

Contractor Selection Process: On March 22, 2017, after a competitive procurement, BAIFA authorized a contract with Econolite (formerly Aegis ITS, Inc.) to provide comprehensive maintenance services, including some construction services, for BAIFA on express lanes highway infrastructure in multiple corridors on a scheduled and as-needed basis. The initial contract authorization of \$2,500,000 included funds for maintenance for three years on the I-680 South Express Lanes in Contra Costa County only. In May 2019, a \$200,000 contract amendment was issued under Executive Director Authority to include and augment funding for fiber repairs. The current contract will expire April 30, 2020, and includes an option to extend for up to three (3) additional years in increments of BAIFA's choosing subject to the adoption of future years' BAIFA operating budgets.

Summary:

This amendment extends the period of performance for an additional three (3) years and allows Econolite to continue for comprehensive maintenance services, including some construction services, for express lanes highway infrastructure on BAIFA's express lanes on a scheduled and as-needed basis. Attachment A includes an estimated budget breakdown. Attachment B includes a summary of Econolite and its project team's small business and disadvantaged business enterprise status.

Recommendation:

Staff recommends that the Authority authorize the Executive Director or designee to negotiate and enter into a contract amendment in an amount not to exceed \$9,000,000 to provide comprehensive maintenance services, including some construction services, for express lanes highway infrastructure on BAIFA's express lanes on a scheduled and as-needed basis, subject to the approval of future BAIFA budgets.
