Distribution of CARES funds must respond to current need, based on COVID pandemic conditions. While nearly all of the funds will and should go to transit agencies to insure workers stay on payroll and riders continue to have transit service, this 5% for public health protection is vital to the lives of both workers and riders.

Responding to the COVID crisis, the number one issue is saving lives.

Over 80 transit workers have died nation-wide and thousands have been infected.

Our goals during and after this pandemic must be (a) to provide essential workers and transit-dependent riders with safe transit service to access essential workplaces and services, and to save the lives of transit workers and riders alike, and (b) to ensure that all transit workers continue to receive full pay and benefits despite reduced service levels. To do so, and to faithfully implement staff's own principle, 5% of the funds should be distributed to a COVID-19 Response Fund, and the remainder should be distributed to transit agencies in proportion to each agency's share of either labor costs or "of the total budgeted FY 2019-20 operating costs for systems across the Bay Area" (i.e., staff's first proposed factor).

The details and rationale for our proposed distribution are as follows: 1. Create a COVID-19 Response Fund with 5% of Phase 1 Federal Revenues. This fund will be made available to every agency based on its actual need for funding to address the health and safety issues facing transit workers and riders during the pandemic and its aftermath. As FTA notes, this was the purpose of the emergency funding. Our entire region is counting on MTC to deploy these emergency resources in a way that flattens the curve and saves the lives of our courageous frontline workers, and the millions who depend on them. Eligible uses of the Bay Area COVID-19 Response Fund should include: a. PPE for all transit workers, including masks, gloves, disinfecting wipes, and hand sanitizer; and plexiglass dividers on vehicles to protect transit drivers b. Masks for every rider who needs one, to protect riders and drivers, and the larger community c. Disinfecting all transit vehicles to state-of-theart standards of virus protection (including hiring new workers, training them in state-of-the-art sanitizing methods, and outfitting them with hazard suits, N95 masks, gloves, and goggles) d. Hazard pay for our heroic transit workers e. Recovery of fares foregone due to rear-door boarding f. Meeting the specific needs of especially vulnerable populations, including people with disabilities, seniors and paratransit

riders If any money remains in this Fund after all needs are met, it can be reallocated as part of Phase 2. If there is a shortfall, it can be augmented as part of that second Phase. 2. Distribute the remaining funding on the basis of total operating budgets or labor cost, not farebox. The bulk of the funds should be distributed solely on the basis of each agency's operating or labor costs, without consideration of pre-COVID farebox recovery. There are two reasons: Keep our transit workers on the payroll: Operating budgets or labor costs are the best indicator of the actual cost for each agency to keep its workers on the payroll over the coming months. The jobs and benefits of our courageous transit workers must be protected during this crisis, and funds should be distributed in proportion to that specific need. This will also support the system's eventual recovery by ensuring sufficient staff is still on payroll. Equity: Distribution based on farebox recovery disproportionately benefits high-fare systems, at the expense of lowfare systems that carry disproportionate numbers of riders of color, transit-dependent riders, and essential workers. (In some cases, highfare systems that previously carried the highest number of riders now carry fewer riders than low-fare systems.)

3. If MTC withholds 1% for "regional transit programs," those funds should be prioritized for pandemic assistance This is not the time for MTC to take nearly \$8 million off the top of the distribution with no pandemic-related specifics for its use. MTC must be transparent in its use of these funds and accountable to spending them to meet needs arising from the COVID-19 pandemic. MTC should focus its resources on providing free inter-system transfers, and identifying and filling gaps in lifeline transit service needed to provide essential workers and transit-dependent riders with access to critical destinations (e.g., hospitals, social services, grocery stores, etc). In this historic crisis, the leadership of our regional transportation agency will literally spell the difference between life and death for workers and residents across the Bay Area. We urge you to take this opportunity to direct 5% of these emergency transit funds to address the crisis, especially at a time when local government resources are stretched so thin.

Good evening MTC Board Members,

I would like to call attention to this Wednesday's upcoming Board Meeting, where the MTC is poised to distribute the CARES funding (to the tune of \$1.3 Billion) to the transit agencies who are in dire need.

Because of the monies dispersed is a proactive approach to triage operating losses under normal circumstance, agencies regionally and nationwide are faced with some critical decisions: at a crossroads of being change agents with the need to make a difference, is it wise to think about how those funds would be used but improve transit connectivity and agency coordination (wholesale). We should be cognizant about making this crisis, and recovery, important to improve customer satisfaction and coordination regardless of us being in "survival mode."

Since transit agencies currently aren't well coordinated with each of the agencies providing a succinct coordination plan, and judging from piecemeal changes that the agencies have performed, I ask you, the MTC, to please evaluate and request improvements with the \$1.3 Billion be made to proactively improve regional transit, and not just triage existing service.

As Seamless Bay Area's policy director Ian Griffiths <u>outlined last week on the Seamless Bay Area blog</u>, MTC should pair these emergency funds with five proactive steps designed to rebuild our region's transit ridership and restore confidence as we emerge from this crisis:

- Develop a region-wide core transit network plan within 30 days
- Eliminate transfer fees and charge riders only one fare
- Eliminate restrictions that prevent transit agencies from transporting passengers in other service areas
- Make transit free for children 12 years of age and under

Develop regionally consistent emergency safety standards for workers and riders

Right now, the MTC has a once-in-a-generation chance to connect emergency transit funding to basic rules like these that require operators to provide unified, customer-focused service.

Without a proactive strategy to rebuild ridership in the coming weeks and months, Bay Area transit will continue on a downward spiral of low revenues, inhibiting our economic recovery, punishing riders with the least means, reinforcing our car dependence, and leaving our society vulnerable to future emergencies.

For these reasons, please make a conscientious effort to transform and improve tour public transit network.

Chair Haggerty and Commissioners:

Public Advocates joined with transit workers and their unions, members of the 6 Wins Network, the Alameda Labor Council, and many others to request a modest but crucial change to the staff recommendation for the distribution of federal CARES Act emergency transit funds.

We are asking you to create, with just 5 percent of the funding, a Bay Area COVID-19 Response Fund.

In the midst of this unprecedented pandemic, our number one priority must be saving lives.

That includes the lives of our courageous transit workers. It also includes the lives of thousands of frontline workers, like nurses and grocery clerks, who continue to ride transit to provide our region with life-sustaining and life-saving services. All of these essential workers are putting their lives, and the lives of their families, at risk daily to serve the millions of other Bay Area residents who shelter in place.

And it includes the many transit-dependent riders -- of which a large proportion are riders of color with disproportionately high infection and death rates -- who continue to ride transit to access those essential services.

Setting aside a small fraction of emergency FTA funds to create a COVID-19 Response Fund provides exactly what we need, right when we need it. It will ensure that all transit workers have the personal protective equipment (PPE) they need; that every rider who needs a face mask has one, that transit agencies are reimbursed for the cost of protective measures like rear-door boarding, and that they can pay their heroic workers the hazard pay they deserve.

Why not just let each agency use some of its own allocation for these purposes? There are several reasons: First, each agency's need for pandemic response measures will be different. In particular, smaller agencies' needs may be larger, on a percentage basis, than those of larger agencies. Second, creating a stand-alone fund that is distributed based on need will incentive every agency to provide the highest level of protection for workers and riders. It will remove any perverse incentives an agency might have to use funds for long-term goals at the expense of meeting the immediate crisis. Finally, by creating this fund, MTC will demonstrate to the entire region that you are bring to this crisis the serious and immediate leadership that is needed.

As local revenues from every source dry up, the infusion of over \$1 billion in federal transit funds through MTC gives our regional agency the chance to lead the way to a safe and

healthy Bay Area. Please take full advantage of that opportunity.

Hello.

My name is Vinita Goyal, I am the Program Officer for Housing and Transportation at Silicon Valley Community Foundation SVCF and a transit rider.

SVCF has five strategic programmatic areas and housing and transportation is one of them. We have pivoted in our response to COVID-19 and are engaging in both short term recovery efforts and mobilizing resources toward long term rebuilding.

We applaud that MTC is supporting our transportation agencies with operating dollars, this is essential as it will allow the agencies to recoup some of the losses from fares and other revenues that they have experienced during the pandemic.

We strongly urge MTC to consider three additional priorities.

First, our transportation infrastructure serves as a backbone for essential workers, transportation workers and other transit dependent communities. During the time of COVID-19, these riders and workers — disproportionately people of color — will face disproportionate rates of infection and death if not protected. So we urge MTC to mandate a budget of safety measures included as part of the expenditure in transportation agencies. During the immediate crisis of the pandemic, not all transit vehicles are being sanitized to state-of-the-art levels, as recommended in guidance from the CDC. While other safety measures are being addressed, including provision of PPE and social distancing through rear-door boarding, the failure to clean vehicles to COVID-19 standards puts riders and essential workers — including transit operators themselves — at serious risk of illness and death.

Second, in your allocation of stimulus funds, please ensure that high fare systems do not inadvertently receive disproportionally higher funds at the expense of low-fare systems that carry disproportionate numbers of riders of color, transit-dependent riders, and essential workers.

Thirdly, this scarcity of resources forces us to think about how to optimize our systems so that they provide the greatest need and yet are critical in our long term recovery. We urge MTC to envision and plan and place a minimum infrastructure that can be scaled up in the future.

Dear Metropolitan Transportation Commission (MTC) Commissioners & Staff:

Please ensure that you reserve 5% of the initial distribution \$1.3 billion you are receiving in Federal CARES Act funding at your meeting on April 22.

That 5% must be used to help save the lives of transit workers in the Bay Area. Nationwide, more than 80 transit workers have already died due to COVID-19. In this global pandemic, the top priority: saving lives. Guidance from the Federal Transit Administration (FTA) begins by stating: "the CARES Act provides funds to prevent, prepare for, and respond to COVID-19..."

Such a reserve - which must be put in a COVID-19 Response Fund - can be used to buy masks, ventilators, and other equipment needed to disinfect and protect workers. In addition, it can be used to provide masks to transit riders who need them. This ensures everyone is properly protected during this global pandemic. Such a fund is needed to insure workers stay on payroll and riders continue to have transit service. This 5% for public health protection is vital to the lives of both workers and riders.

Please support the Amalgamated Transit Union and all transit workers who ask that fully **5% of** the of the first distribution of \$1.3b in CARES Act funding be dedicated to a COVID-19 Response Fund.

CARES funds must be used to respond to current need. While nearly all of the funds will and should go to transit agencies to ensure workers remain on pay status and riders continue to have transit service, **commitment of 5% for public health protection is vital to the lives of both workers and riders**.

Responding to the COVID crisis, the number one issue is saving lives. We know already that 80 transit workers have died nation-wide and thousands have been infected. These numbers may well turn out to be a gross underestimate of the impact of the virus on transit workers. Here in the Bay Area, our essential workers and the riders who depend on them, essential workers themselves, need the protections a COVID-19 Response Fund will create.

Chair Haggerty and Commissioners:

Urban Habitat has joined with Bay Area transit workers and their unions, members of the 6 Wins Network, the Alameda Labor Council, and allied community organizations and advocates to request a modest but crucial change to the staff recommendation for the distribution of federal CARES Act emergency transit funds.

We are asking you to create, with just 5 percent of the funding, a Bay Area COVID-19 Response Fund.

In the midst of this unprecedented pandemic, our number one priority must be protecting the lives, health, and safety of Bay Area essential workers and residents.

That includes the lives of our courageous frontline workers including transit workers, nurses and grocery clerks, who continue to ride transit to provide our region's most basic needs. All of these essential workers are putting their lives, and the lives of their families, at risk daily to serve the millions of other Bay Area residents who shelter in place.

And it includes the many transit-dependent riders -- of which a large proportion are riders of color with disproportionately high infection and death rates -- who continue to ride transit to access those essential services.

Setting aside a small fraction of emergency FTA funds to create a COVID-19 Response Fund provides exactly what we need, right when we need it. It will ensure that all transit workers have the personal protective equipment (PPE) they need; that every rider who needs a facemask has one, that transit agencies are reimbursed for the cost of protective measures like rear-door boarding, and that they can pay their heroic workers the hazard pay they deserve.

We believe this need is too important to be left to individual transit agencies to budget for. We know that each agency's need for pandemic response measures will be different. Creating a stand-alone fund that is distributed based on need will incentive every agency to provide the highest level of protection for workers and riders. It will prioritize the most immediate needs and deter the use of these funds for long-term goals. By creating this fund, MTC will demonstrate to the entire region that you are providing the leadership this crisis demands.
