Subject:

Final Plan Bay Area 2050

Presentation on Final Plan Bay Area 2050, the region's next-generation long-range plan, including revisions made based upon public and stakeholder feedback since the spring 2021 release of Draft Plan Bay Area 2050. The Metropolitan Transportation Commission and ABAG Executive Board will meet jointly on October 21 to consider Final Plan Bay Area 2050 for adoption.

Background:

The ABAG Administrative Committee met jointly with the MTC Planning Committee on October 8, 2021 and received the staff report on Final Plan Bay Area 2050. The ABAG Administrative Committee forwarded ABAG Resolutions 08-2021 and 09-2021 to the ABAG Executive Board for approval. The MTC Planning Committee has forwarded MTC Resolutions 4482, 4484, 4485, and 4475 to the Commission for approval.

At its joint meeting on October 21, 2021 the ABAG Executive Board and the Metropolitan Transportation Commission will receive the staff report on Final Plan Bay Area 2050, including the final air quality conformity analysis, final environmental impact report, final plan, and associated amendment to the Transportation Improvement Program.
