Adoption of ABAG Resolution No. 2-2025 authorization to enter into an agreement with the State Coastal Conservancy for up to \$2 million to implement the Palo Alto Horizontal Levee Project

Background:

The San Francisco Estuary Partnership (SFEP) is one of 28 programs mandated under Section 320 of the Clean Water Act, the National Estuary Program (NEP). SFEP has been working with the City of Palo Alto under a Cooperative Agreement to implement the Palo Alto Horizontal Levee Project.

The goals of the Project are to enhance the ecological function of the Harbor Marsh and improve resilience to sea level rise. The Project began design in 2018, supported by funding from the US Environmental Protection Agency. In 2024, SFEP applied and was approved for funding from the California State Coastal Conservancy for \$2 million. The additional funding will close a critical funding gap and allow for construction of the Palo Alto Horizontal Levee Project. The California State Coastal Conservancy is a California state agency.
