




I-680 Contra Costa Express Lanes Policies

- Tolling Hours are 5 a.m. to 8 p.m. Monday Friday.
- All drivers must have a FasTrak[®] account to avoid penalties.
 - Solo drivers can carry a standard FasTrak tag* or a FasTrak Flex[®] tag set to 1 or pay tolls via license plate.
 - Carpools (2+) travel toll-free with FasTrak Flex toll tags set to 2 or 3+.
 - Motorcycles travel toll-free with FasTrak Flex toll tags set to 3+.
 - Solo-drivers in eligible clean-air vehicles (CAV) pay half- price tolls with FasTrak CAV toll tags set to 1.
- * Standard FasTrak tags do not have a switch and were issued prior to January 2020.





I-680 Contra Costa Express Lanes – Q2 2024 Highlights

 2.4 million express lane trips were made in Q2 2024. The Average Daily Trip count (ADT) and total trips increased 8% from the prior quarter (Q1 2024). Compared to a year ago (Q2 2023), total trips increased 4% and ADT increased by 2%. The goal of express lanes is to maximize lane use while keeping traffic moving to encourage carpooling and transit ridership.

- The share of toll-free HOV 2+ trips was 41%, down 1% from Q1 2024 and the same as Q2 2023. This share has ranged between 30% and 46% per quarter over the history of the lanes and was at its highest in Q1 2020.
- 9% of express lane trips were violations unpaid trips made without a FasTrak account down 2% from Q1 2024 and Q2 2023.
- Q2 2024 toll revenue was \$3.9M, up 22% from Q1 2024, and up 9% from Q2 2023. Tolled trips increased 14% from Q1 2024 and increased 8% from Q2 2023. The average toll paid increased 7% from Q1 2024 and increased 1% from Q2 2023.




I-680 Contra Costa Express Lanes – Q2 2024 Performance Highlights, continued

- Corridor-length northbound travel was slowest between 4:00 p.m. and 5:00 p.m. when express lane speed averaged 66 mph (10 mph faster than the general-purpose lanes) and the average toll paid peaked at \$8.50.
- Corridor-length southbound travel was slowest between 8:00 a.m. and 9:00 a.m. when express lane speed averaged 67 mph (10 mph faster than the general-purpose lanes) and the average toll paid peaked at \$6.90.
- CHP made 1,439 enforcement contacts, of which 42% resulted in citations related to carpool occupancy. Enforcement contacts were up 1.5% and occupancy citations were up 18% compared to Q2 2023.



I-680 Express Lane Trips

2.4 million express lane trips were made in Q2 2024. Trips were up 8% from the prior quarter (Q1 2024) and up 4% from Q2 2023.






I-680 Average Daily Express Lane Trips

The Average Daily Trip (ADT) count from April 1, 2022 through June 30, 2024 was 35,828. Q2 2024 ADT was about 37,900, an 8% increase from the prior quarter and a 2% increase from a year ago (Q2 2023).



I-680 Express Lanes Tolls

67.1%

Drivers made 1,195,179 tolled express lane trips in the quarter, up 8% from a year ago (Q2 2023). About 67% of these trips were tolled less than \$3 while about 6% were tolled \$12 or higher.

The Q2 2024 share of trips tolled less than \$3 decreased compared to a year ago (67% compared to 70%) and the share tolled \$9 or higher increased from 11.6% to 12.3%.

In Q2 2024 the average toll paid was \$3.28, compared to \$3.26 in Q2 2023, 1% higher.

The northbound average toll paid peaked at \$8.50 around 4 p.m., \$1.00 more than a year ago.

The southbound average toll paid peaked at \$6.90 at 8 a.m., \$0.50 more than a year ago.



I-680 Express Lanes CHP Enforcement



CHP provided 1,224 enforcement hours in the quarter, filling 95% of requested hours and resulting in 1,439 enforcement contacts.

42% of Q2 2024 contacts were related to carpool occupancy violations.

The average cost to BAIFA per enforcement contact was \$125.



I-880 Express Lanes – Q2 2024 Performance Highlights

- 4.5 million express lane trips were made in Q2 2024. The Average Daily Trip count (ADT) of 69,600 was up 7% from the prior quarter (Q1 2024) and up 5% from a year ago (Q2 2023).
- The share of toll-free HOV 3+ trips was 43%, down 1% from Q1 2024 and up 3% from Q2 2023. The share of half-price HOV 2 trips was 6%, down 1% from the prior quarter (Q1 2024) and last year (Q2 2023).

The goal of express lanes is to maximize lane use while keeping traffic moving to encourage carpooling and transit ridership.

- 10% of express lane trips were violations trips made without a FasTrak account. The share was down 2% from the prior quarter (Q1 2024) and 2% from the prior year (Q2 2023).
- Quarterly toll revenue was up 29% from the last quarter and up 9% from a year ago (Q2 2023). Tolled trips were up 10% and 4% from Q1 2024 and Q2 2023, respectively. The average toll paid was up 17% from Q1 2024 and up 5% from Q2 2023.




I-880 Express Lanes – Q2 2024 Performance Highlights, continued

- Corridor-length northbound travel was slowest between 5 p.m. and 6 p.m. when express lane speed averaged 49 mph (15 mph faster than the general-purpose lanes). The northbound average toll paid peaked at \$14.90 around 4 p.m.
- Corridor-length southbound travel was slowest between 8 a.m. and 9 a.m. when express lane speed averaged 58 mph (14 mph faster than the general-purpose lanes). The southbound average toll paid peaked at \$11.90 around 7 a.m.
- CHP spent 2,390 hours patrolling the I-880 express lanes, resulting in 2,541 enforcement contacts. Of those, 16% resulted in citations for crossing double white lines and 36% in citations related to carpool occupancy.




I-880 Express Lane Trips

4.5 million express lane trips were made in Q2 2024. Trips were up 8% from the prior quarter (Q1 2024) and up 7% from a year ago (Q2 2023).

The Average Daily Trip (ADT) count from April 1, 2022 through June 30, 2024 was 64,943. Q2 2024 ADT was about 69,600, a 7% increase from the prior quarter and a 5% increase from a year ago (Q2 2023).





I-880 Express Lane Tolls


Drivers made 2,126,736 tolled express lane trips in the quarter, up 4% from a year ago (Q2 2023). Around 33% of these trips incurred a toll less than \$3 and 17% were for tolls \$12 or higher.

The share of trips tolled less than \$3 decreased from a year ago (36.5% compared to 33%) and the share tolled trips \$12 or higher increased from 15.1% to 17%.





I-880 Express Lanes CHP Enforcement



CHP provided 2,390 enforcement hours in the quarter, filling 94% of requested hours and resulting in 2,541 enforcement contacts.

Per MTC request, CHP officers spend more time stationed in the observation areas instead of roaming the corridor, acting as a deterrent but resulting in fewer enforcement contacts.

The average cost to BAIFA per enforcement contact was \$136. 36% of Q2 2024 enforcement contacts were related to carpool occupancy violations.
