# Proposed BAIFA Toll Facility Ordinance Amendment

## History of Toll Facility Ordinance

- Background: Bay Area express lanes are operated by multiple agencies. MTC received state approval to operate a 270-mile express lane network on I-880, I-680 and I-80 from the California Transportation Commission in 2011. MTC's express lanes are operated by the Bay Area Infrastructure Financing Authority (BAIFA), a joint powers authority between MTC and the Bay Area Toll Authority (BATA).
- Purpose of Ordinance:
  - Documents BAIFA's toll policy
  - Allows BAIFA to enforce toll violations
- Originally adopted July 2016 before I-680 opened
- Amended three times:
  - January 2020 add I-880 and clean air vehicle tolling
  - September 2020 add I-680 extension
  - June 2022 enable pilots, allow changes to violation penalties by board resolution, and define Executive Director's authority in emergencies





**Proposed Toll Ordinance Changes in 2025** 


- Add the I-80 Express Lanes in Solano County, which are scheduled to open in Fall 2025
- Increase the allowable timeframe and parameters for pilot projects on express lanes
- Increase the minimum toll per zone from \$0.50 to \$0.75 for all BAIFA Express Lanes
- Clarify that the Clean Air Vehicle (CAV) discount will end in Sep-2025, unless federal law is amended prior to that date
- Adjust the boundaries of the toll zones on southbound I-680 to reflect the gap closure between BAIFA's and Alameda CTC's express lanes on I-680.





## **Operations Policies for I-80**

- Existing HOV lane on I-80 operates in peak hours as HOV2
- When the Express Lanes open:
  - Hours of operation = 5 am to 8 pm
  - HOV eligibility = 3 or more persons
- BAIFA and Caltrans are partnering on a planned pilot of weekend tolling
  - Same hours and HOV eligibility would apply 7 days a week
  - Pilot would begin at the same time as start of toll operations
  - Separate BAIFA approval would be required, after toll ordinance is amended





#### **Toll Policies for I-80**

- Proposed toll policy would be consistent with open HOV3+ Express Lanes on I-880, U.S. 101, and SR-237
  - Carpool discount Solo drivers pay full price; HOV2 and CAV pay half price; HOV3+ pays no toll
  - FasTrak® Required All vehicles must use FasTrak account, even those eligible for free trip
  - Enforcement and Penalties Automatic enforcement with license plate cameras for toll violations; same penalties as other Bay Area Express Lanes; CHP enforcement for occupancy violations & safety concerns
- BAIFA is also considering expanding the Express Lanes START pilot program to the I-80 corridor
  - Current pilot offers eligible low-income drivers discounted tolls on I-880
  - Expansion to I-80 would ease transition at the start of tolling
  - Separate BAIFA approval would be required, after toll ordinance is amended

- Legal notice
  - Announces intent to amend ordinance
  - Published in four major county newspapers, plus Spanish and Chinese language papers
- Public comment period
  - At least 30 days
- Public hearing
  - Interpreters provided on request

- Press release
  - Highlight opportunity for public input
- Website information
  - Landing page with FAQs
- Social media
  - Targeted digital ads in English, Spanish, Chinese, and Tagalog
  - Two waves to align with press release and lead-up to hearing
  - Social media press kit to be shared with CBO partners
