Consultant Bench – 2024 Municipal Advisory Services – Cycle 1 for Service Category: Conduit Financing (CSG Advisors Incorporated and KNN Public Finance, LLC)

## **Subject:**

Request for Commission approval of:

- 1) a pre-qualified list of firms (Bench) from which ABAG Finance Authority for Nonprofit Corporations and Advancing California Finance Authority (ABAG FAN/ACFA) may contract with approved firms on an as-needed basis to provide municipal advisory services for ABAG FAN/ACFA. The Commission is authorized to approve the Bench under the Contract for Services between MTC and ABAG. The Bench Performance Period will end on June 30, 2029, with the option to extend for two (2) additional years. The Bench will consist of CSG Advisors Incorporated and KNN Public Finance, LLC.
- 2) delegation of authority to the Metropolitan Transportation Commission (MTC) to hear and decide upon any protests related to the aforementioned procurement.

#### **Background:**

ABAG FAN/ACFA currently have approximately \$1 billion in conduit debt outstanding which requires municipal advisory service firms to assist in the ongoing administration of the portfolio. Additionally, ABAG FAN/ACFA may require municipal advisory service firms to assist in the issuance of debt and restructuring of existing transactions.

#### **Procurement Process:**

In March 2024, MTC and the agencies staffed by MTC, including ABAG FAN/ACFA, issued a Request for Qualifications (RFQ) for Municipal Advisory Services to develop a list of firms to serve as a Bench to provide as needed municipal advisory services for the following service categories: 1) Transportation Financing (BATA and BAIFA); 2) Swap Advisory (BATA); 3) Conduit Financing (ABAG); 4) General Obligation (GO) Financing (BAHFA), and 5) Housing Project Revenue Financing (BAHFA). The Bench Performance Period will be until June 30, 2029, with the option to extend for two (2) additional years. The RFQ specified that ABAG FAN/ACFA may elect to use the Bench as needed. The RFQ also specified that consultants may

apply for selection to the Bench in the service category of Conduit Financing pertaining to ABAG FAN/ACFA.

On April 12, 2024, Statements of Qualifications (SOQs) were received from three (3) firms for the ABAG's Service Category: Conduit Financing (ABAG): CSG Advisors Incorporated, KNN Public Finance, LLC, and Montague DeRose and Associates, LLC. The SOQs were evaluated based upon the following evaluation criteria specified in the RFQ: 1) Firm and staff qualifications and experience with advisory services; 2) Relevant experience by Service Category applied for; 3) SOQ quality, completeness, and clarity; 4) Demonstrated commitment to equity; 5) Cost.

Based on the evaluation, staff is recommending CSG Advisors Incorporated and KNN Public Finance, LLC to the Bench for the Municipal Advisory Services Bench for the Conduit Financing service category, as summarized in Attachment A. These firms have significant municipal debt issuance and advisory experience. KNN Public Finance, LLC is a Small Business Enterprise. CSG Advisors Incorporated is neither a small business nor a disadvantaged business enterprise.

Finally, in the event of any protests related to the Bench, such protests will be submitted to MTC for review.

#### **Issues:**

None identified.

#### **Recommendation:**

Staff recommends that the Commission approve the pre-qualified firms identified in Attachment A to the Bench under Service Category: Conduit Financing to provide municipal advisory services to ABAG FAN/ACFA on an as-needed basis from date of approval through June 30, 2029, with the option to extend for two (2) additional years. Staff also recommends that the Authority delegate to MTC the authority to hear and decide upon any protests related to the aforementioned procurement.
