Contract Amendment – Third Party Independent Transit Operator Review: Macias Gini & O'Connell, LLP (\$60,000)

## Subject:

A request to authorize a contract amendment in an amount not to exceed \$60,000 and extension through June 30, 2025, with Macias Gini & O'Connell, LLP (MGO) to conduct an independent third-party review of transit operators' budget deficits and fair-share contributions under the proposed regional revenue measure.

## **Background:**

MTC entered into contract with MGO to conduct an independent review of projected budget deficits for specific Bay Area transit operators, as well as a review of local funding contributions to BART and Caltrain. The purpose of this work is to ensure full transparency, consistent financial modeling and reporting of operating deficits across the relevant transit operators, and to develop a transparent factual record that can be used to support and inform ongoing discussions among policy makers regarding fair-share contributions, included as part of the proposed regional revenue measure through Senate Bill 63. MGO was selected from an informal procurement and contracted in the amount of \$187,500 through April 30, 2025. Additional tasks have been identified as necessary to complete the review. This proposed contract amendment to add an amount not to exceed \$60,000 and extend the contract term through June 30, 2025, will allow funding and time to complete the additional tasks.

#### **Issues:**

#### **Recommendations:**

Staff recommends that the Committee authorize the Executive Director or designee to negotiate and enter into a contract amendment with Macias Gini & O'Connell, LLP to extend the term through June 30, 2025 and add an amount not to exceed \$60,000 for a total contract not to exceed of \$247,500.
