MTC Resolution Nos. 3989, Revised; 4202, Revised; 4505, Revised; and 4540, Revised

Subject:

Various revisions to the One Bay Area Grant (OBAG 2 and 3), Carbon Reduction Program (CRP), and MTC exchange programs, including programming \$40.7 million to local agencies for various Transit Oriented Communities (TOC) capital projects and \$20.8 million to MTC for various local TOC planning projects.

Background:

The OBAG 2 and 3 programs establish the policy and programming framework for investing federal Surface Transportation Block Grant Program (STP) and Congestion Mitigation and Air Quality Improvement program (CMAQ) funds for FY 2017-18 through FY 2025-26. MTC approved the policy and programming framework for investing federal Carbon Reduction Program (CRP) funds for FY 2021-22 through FY 2025-26 as part of the broader OBAG 3 regional investment strategy.

MTC's fund exchange program provides greater flexibility to deliver select priority projects within the broader OBAG framework. MTC Resolution No. 3989, Revised, describes the procedures governing MTC's exchange program and details the agreements and commitments that have been made to date. The program facilitates funding agreements with partner agencies to exchange federal STP/CMAQ funds with non-federal local funds. These exchanges do not increase the total amount of funds available to the region but enable MTC to support key investments within the OBAG policy framework that are ineligible for STP/CMAQ funds.

This month, staff recommend revisions to the OBAG 2 and 3, CRP, and MTC exchange programs as summarized in **Table 1** below and detailed in **Attachment A**.
