Contract – Bay Bridge Forward (BBF): Interstate 580 Westbound High Occupancy Vehicle Lane Extension – MNS Engineers, Inc. (\$1,030,000)

#### Subject:

Request for Committee approval to negotiate and enter into a contract with MNS Engineers, Inc., to provide Construction Management services for the BBF: Interstate 580 (I-580) Westbound (WB) High Occupancy Vehicle (HOV) Lane Extension project (Project), in an amount not to exceed \$1,030,000.

#### **Background:**

As part of the Bay Bridge Forward Initiative, the I-580 Westbound HOV Lane Extension Project (Project) proposes to convert approximately 2.3 miles of an existing general-purpose (GP) lane on westbound Interstate 580 (I-580) to an HOV lane from the beginning of the existing HOV lane near the San Francisco-Oakland Bay Bridge (SFOBB) Toll Plaza approach to just east of the Broadway-Richmond Boulevard Undercrossing. Given the worsening congestion associated with the SFOBB traffic, MTC has been seeking solutions to improve the traffic operations along the I-580 corridor. Solutions to reduce congestion on this corridor are limited by the constrained right of way. The proposed GP to HOV lane conversion will provide travel time savings for buses and HOV and hence encouraging mode shift. The Project is anticipated to increase person throughput during peak hours. The project has obtained environmental clearance for the National Environmental Policy Act (NEPA) and the California Environmental Quality Act (CEQA). The project has also obtained Caltrans approval for final design.

#### **Procurement Process:**

On October 2, 2024, MTC issued a Request for Qualifications for Construction Management Services for the BBF: I-580 WB HOV Lane Extension project ("RFQ") inviting firms to submit Statements of Qualifications ("SOQ") for this project.

In response to the RFQ, MTC received SOQs from three proposers: ABA Global, Inc; MNS Engineers, Inc.; and Zoon Engineering. An evaluation panel comprised of MTC and Caltrans staff reviewed the SOQs based upon the following evaluation criteria specified in the RFQ:

Evaluation Criteria	Percentage
1) Qualifications and experience of the team and key personnel	40%
2) Firm's understanding of the project	20%
3) Firm's work plan to completing the work	20%
4) Past performance of the prime, based on references and information	10%
learned about past projects	
5) Written, visual, and oral presentation	10%
Possible Total:	100%

After the initial evaluations held on December 5, 2024, the panel shortlisted MNS Engineers, Inc., and Zoon Engineering for further consideration. The two firms were interviewed on December 13, 2024. Based on the results of the interviews and the SOQ evaluations, the panel recommends the ranking of firms below with selection of MNS Engineers, Inc. as the highest ranking firm. MNS Engineers, Inc., and its subconsultants have demonstrated a clear understanding of the project scope and potential challenges and have presented a strong approach that meets the expectations of the panelists.

The table below provides the final ranking based upon the panel's evaluations:
