


Bus Accelerated Infrastructure Delivery (BusAID) Program Recap

- Transit Transformation Action Plan (TAP) initiative focused on:
 - Near-term (quick-build) projects
 - "Hotspots" that reduce transit travel times and improve transit reliability
- Round 1 (May 2024): eight projects totaling \$18M
 - o Project inventory: 87 projects from 21 transit operators
 - 24 high-performing projects advanced to feasibility/readiness assessment review
 - 16 deferred due to project readiness or \$5M/agency funding cap
 - 8 projects awarded funding

BusAID Round 1.2

- Bonus Augmentation of Round 1, limited to:
 - High-performing projects that were not ready in Round 1
 - Transit agencies that did not exceed \$5 million funding award cap in Round 1
- Received one project submission totaling \$2 million:
 - SamTrans El Camino Real Corridor-Wide Planning



IDEA TSP Call for Technical Assistance




- Innovative Deployments to Enhance Arterials: Transit Signal Priority (IDEA TSP) grants for technical assistance to support the planning and design phases of TSP projects.
 - TSP implementation
 - Signal timing optimization
 - Other signal-related transit priority elements
- MTC will lead procurement of consultants through existing Consultant Benches.
- Five projects recommended for funding
 - Total: \$1.9 million
 - Projects anticipated to kick-off in mid 2025, and be completed within 18-24 months


- Publicized through Arterials Operations Committee, Transit Priority Working Group, Transit Finance Working Group and other relevant groups


