Contract Amendment – On-Call Bay Area Transit Coordination and Structure Consultant Bench: Regional Network Management Implementation: VIA – A Perkins Eastman Studio (\$250,000)

# **Subject:**

Request for approval of a contract amendment with VIA- A Perkins Eastman Studio (VIA) to conduct an evaluation of the Regional Network Management (RNM) framework in an amount not to exceed \$250,000, which would increase the total not to exceed amount to \$600,000.

### **Background:**

In May 2023, the Administration Committee approved a \$350,000 contract with VIA to support time-sensitive actions that were recommended as part of the Regional Network Management Business Case Evaluation (February 2023) to implement the initial components of the regional transit network management framework. The VIA-led consultant team provided support on: finalizing the implementation plan for regional transit network management, developing regional transit network management charters, development of key performance indicators (KPIs), and development of program management tools.

In May 2024, the RNM Committee adopted performance measures by which regional transit and the RNM would be assessed (MTC Resolution No. 4648). Performance measures will help deliver on the RNM's Mission by measuring regional transit outcomes for riders, providing information to hold the RNM accountable for progress on regional transit initiatives, and helping to inform the continuous improvement of the RNM framework. A key aspect of assessing performance is evaluating the RNM framework itself, including: current and planned RNM capabilities, identifying recommendations/actions that benefited or were challenged by the current RNM design (e.g., collaboration, visibility, efficiency), and identifying resources needed to support RNM activities.

To support this work, staff recommends an amendment of \$250,000 to VIA's contract. Under the proposed contract amendment, VIA will engage with MTC staff and other key stakeholders to conduct an assessment of the RNM framework including identifying strengths, weaknesses, opportunities and challenges with the existing RNM framework and developing recommendations on how to evolve the RNM moving forward.

Staff recommend VIA for this work due to the team possessing the needed institutional knowledge of network management structures including their development and operation. Given that the VIA team led the development of the Regional Network Management Business Case Evaluation and supported the implementation of the RNM framework, the VIA team has the context and understanding of the current environment that will allow them to progress this work quickly and with no repetition of work.

Attachment A includes a summary of VIA and its project team's small business and disadvantaged business enterprise status.

#### **Recommendations:**

Staff recommends that the Regional Network Management Committee authorize the Executive Director or designee to negotiate and execute a contract amendment with VIA in an amount not to exceed \$250,000 and to extend the term from June 30, 2024, to December 31, 2025, to conduct an assessment of the RNM framework.
