MTC Resolution No. 4646, Revised. 2025 Transportation Improvement Program (TIP)
Amendment 2025-28

Subject:

Request referral of MTC Resolution No. 4646, Revised, to the Commission for approval.

Background:

The TIP is a comprehensive listing of San Francisco Bay Area surface transportation projects that are federally funded, require a federal action, or are considered regionally significant for air quality purposes. The TIP is updated every two years, as required by state statute, and is revised as needed through amendments or administrative modifications.

Adopted by the MTC Commission in September 2024, the 2025 TIP includes transportation projects and funding for the four-year period from federal fiscal year (FY) 2024-25 through 2027-28. The TIP is posted on MTC's website at: <https://mtc.ca.gov/funding/transportation-improvement-program-tip>.

Amendment 2025-28 revises four existing projects in the 2025 TIP with a net funding increase of approximately \$11.2 million and serves to conform the 2025 TIP to *Plan Bay Area 2050+*.

Among other changes, this revision:

- Updates the funding plans or project details of four projects with regional Surface Transportation Block Grant/Congestion Mitigation and Air Quality Improvement Programs (STP/CMAQ) funds; and
- Demonstrates that the 2025 TIP, as revised, is consistent with *Plan Bay Area 2050+*.

The project changes included in this revision (Attachment C) demonstrate that the 2025 TIP, as revised, is consistent with *Plan Bay Area 2050+*. Changes made with this revision do not conflict with the financial constraint requirements. The Transportation-Air Quality Conformity Analysis for *Plan Bay Area 2050+* and Amended 2025 TIP that is being considered under

Agenda Item 8b demonstrates that the TIP and Plan are consistent with (“conform to”) the federal air quality plan known as the State Implementation Plan (SIP).

The TIP public participation process, including this amendment notice, serves to satisfy the public involvement requirements of the Federal Transit Administration (FTA) annual Program of Projects (POP) for applicable funds. Public notice of public participation activities and time established for public review of and comments on the TIP will satisfy the FTA Section 5307 POP requirements.

Staff will transmit this amendment to Caltrans after Commission approval. Caltrans will then forward the amendment to FTA and Federal Highway Administration (FHWA) as required for final federal agency review and approval.

Issues:

This revision to the 2025 TIP contains programming changes that are contingent upon:

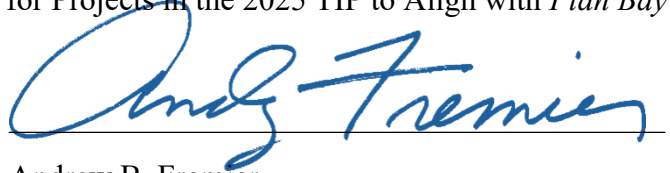
- The Commission’s approval of Item 8b (MTC Resolution No. 4748 - Final Air Quality Conformity Analysis)
- The Commission’s and ABAG Executive Board’s approval of Item 8c (MTC Resolution No. 4749 and ABAG Resolution No. 01-2026 - Final Environmental Impact Report (EIR))
- The Commission’s and ABAG Executive Board’s approval of Item 8d (MTC Resolution No. 4750 and ABAG Resolution No. 02-2026 - *Plan Bay Area 2050+*).
