Report on the operations of MTC's Interstate-680 (I-680) Contra Costa and Interstate-880 (I-880) Alameda Express Lanes.

Express Lanes Operations:

The Quarter 4 (Q4) 2024 BAIFA Express Lanes key operational statistics and their quarter-over-quarter and year-over-year trends are summarized in the following table.

The quarterly increases in the I-680 average toll paid and toll revenue are primarily due to growing traffic which precipitated a change in the toll algorithm to manage demand and increased the amount of time when high tolls were reached. Additionally, tolls collected from past violation trips and revenue reporting practices contributed to the increase in toll revenue in Q4 2024.

The quarterly decline in I-880 toll revenue is the result of a 6% decline in the number of paid trips.
