Contract Amendment Correction - Bay Area Regional Energy Network (BayREN) for Shared Technical and Regulatory Support Services: The Energy Coalition (\$100,000)

#### Subject:

Authorization to correct a previously approved contract amendment with The Energy Coalition in the amount of \$100,000, for a cumulative total amount not to exceed \$750,000, to provide shared technical and regulatory support services for the Bay Area Regional Energy Network (BayREN) and Tri-County Regional Energy Network (3C-REN) through December 31, 2025.

### **Background:**

In the September 19, 2024 ABAG Executive Board meeting, BayREN brought forward a contract amendment, item 6.d., with The Energy Coalition, in an amount not to exceed \$100,000, for a cumulative total amount not to exceed \$650,000, to provide shared technical and regulatory support services for the Bay Area Regional Energy Network (BayREN) and Tri-County Regional Energy Network (3C-REN) through December 31, 2025.

There was an error in stating the cumulative total amount not to exceed was \$650,000. The item should have stated the cumulative total amount of not to exceed \$750,000. This item, if approved, corrects that error.
