Subject:

Request for Authority approval of:

- a pre-qualified list of firms (Municipal Advisory Services Bench for General Obligation (GO) Financing Service Category) from which BAHFA may contract with approved firms on an as-needed basis to provide municipal advisory services for BAHFA. The Bench's Performance Period will end on June 30, 2029, with the option to extend for two (2) additional years. The Bench will consist of KNN Public Finance, LLC and Public Resources Advisory Group, Inc. for the GO Financing service category.
- 2) a pre-qualified list of firms (Municipal Advisory Services Bench for Housing Project Revenue Bonds Service Category) from which BAHFA may contract with approved firms on an as-needed basis to provide municipal advisory services for BAHFA. The Bench's Performance Period will end on June 30, 2029, with the option to extend for two (2) additional years. The Bench will consist of CSG Advisors Incorporated Inc. and KNN Public Finance, LLC for the Housing Project Revenue Bonds service category.
- delegation of authority to the Metropolitan Transportation Commission (MTC) to hear and decide upon any protests related to the aforementioned procurements.

Background:

Staff is working on several initiatives of high priority for the Authority, including a potential 2024 housing bond measure to support regionwide housing production and preservation. To assist in the issuance of debt, staff requires the support of experienced municipal advisory firms.

Procurement Process:

In March 2024, MTC and the agencies staffed by MTC, including BAHFA, issued a Request for Qualifications (RFQ) for Municipal Advisory Services to develop a list of firms to serve as a Bench to provide as needed municipal advisory services. The Bench Performance Period will be until June 30, 2029, with the option to extend for two (2) additional years. The RFQ specified that BAHFA may elect to use the Bench as needed. The RFQ also specified that consultants may apply for selection to the Bench in the service categories of General Obligation (GO) Financing and/or Housing Project Revenue Bonds pertaining to BAHFA.

On April 12, 2024, Statements of Qualifications (SOQs) were received from five (5) responsive firms for the GO Financing category. Staff recommends two of these five firms for appointment

to the bench. Additionally, SOQs were received from three (3) firms for the Housing Projects Revenue Bonds and two firms are recommended for appointment to the bench. The SOQs were evaluated based upon the following evaluation criteria specified in the RFQ: 1) Firm and staff qualifications and experience with advisory services; 2) Relevant experience by Service Category applied for; 3) SOQ quality, completeness, and clarity; 4) Demonstrated commitment to equity; and 5) Cost. Interviews were conducted with a short list of firms consisting of KNN Public Finance, LLC and Public Resources Advisory Group, Inc. for the GO Financing service category.

Based on the evaluation, staff is recommending the appointment of KNN Public Finance, LLC and Public Resources Advisory Group, Inc. to the Municipal Advisory Services Bench for the GO Financing service category, as summarized in Attachment A. Staff is also recommending the appointment of CSG Advisors Incorporated and KNN Public Finance, LLC to the Municipal Advisory Services Bench for the Housing Project Revenue Bonds service category, as summarized in Attachment B. These recommended firms have significant municipal debt issuance and advisory experience with particular experience and expertise in the specific service categories. The firms' Small Business Enterprise and Disadvantaged Business Enterprise statuses are listed in Attachment C.

Finally, in the event of any protests related to either of these two benches, such protests will be delegated and submitted to MTC for review.

Issues:

None identified.

Recommendation:

Staff recommends that the Authority approve the Municipal Advisory Services Bench for Service Category: 1) GO Financing to include KNN Public Finance, LLC and Public Resources Advisory Group, Inc. to provide municipal advisory services on an as-needed basis from the date of approval through June 30, 2029, with the option to extend for two (2) additional years; and 2) the Municipal Advisory Services Bench for Service Category: Housing Project Revenue Bonds to include CSG Advisors Incorporated and KNN Public Finance, LLC to provide municipal advisory services on an as-needed basis from the date of approval through June 30, 2029 with the option to extend for two (2) additional years. Staff also recommends that the Authority delegate to MTC the authority to hear and decide upon any protests related to the aforementioned procurements.
