Purchase Order and/or Contract – ERP Data Conversion Professional Services, Koa Hills Consulting, LLC (\$400,000)

Subject:

Authorization to negotiate and enter into a sole source Purchase Order and/or Contract with Koa Hills Consulting, LLC, in an amount not to exceed \$400,000 for data conversion professional services for the ERP implementation project ('Project').

Background:

At the June 2024 Commission meeting, staff provided an update on the ERP Program including the ERP capital budget. The ERP migration from Central Square to Oracle is proceeding as planned. MTC project staff planned to rely on outside assistance from Central Square in migrating data from the existing financial system (Central Square) to the new Oracle system; however, the company has not responded to requests for a proposal to complete this work. To respond to this need, MTC staff researched firms with direct technical knowledge of the existing financial system. Koa Hills Consulting is known for employing resources who were former Central Square database engineers and for supporting public sector agencies with data migration from Central Square to Oracle. In initial conversations, Koa Hills' quote shows understanding of the scope MTC requires.

This is a sole source arrangement with Koa Hills Consulting, LLC, based on the team's specific experience and knowledge of data conversion and migration from Central Square to Oracle. The proposed purchase order and/or contract will provide professional services needed for data extraction, data mapping, creation of import files, troubleshooting of data issues, and participation in project team meetings, as needed, for a period beginning March 1, 2025 and ending April 1, 2026. The requested budget of \$400,000 is included in the ERP Capital Budget and is consistent with the system integration scope.

Koa Hills Consulting, LLC, is neither a disadvantaged business enterprise nor a small business enterprise.

Recommendation:

Staff recommends that the Committee authorize the Executive Director or designee to negotiate and enter into a purchase order and/or contract in an amount not to exceed \$400,000 with Koa Hills Consulting, LLC, for ERP data conversion professional services.
