## METROPOLITAN TRANSPORTATION COMMISSION RESOLUTION NO. 4680

WHEREAS, the Metropolitan Transportation Commission (MTC) is the regional transportation planning agency for the San Francisco Bay Area pursuant to Government Code 66500 *et seq.*; and

WHEREAS, the Moving Ahead for Progress in the 21st Century Act (MAP-21) requires that projects funded through the Enhanced Mobility of Seniors and Individuals with Disabilities Program be included in a locally developed Coordinated Public Transit-Human Services Transportation Plan (Coordinated Plan) beginning in Fiscal Year 2013; and

WHEREAS, the Fixing America's Surface Transportation (FAST) Act requires that projects funded through the Enhanced Mobility of Seniors and Individuals with Disabilities Program be included in a locally developed, Coordinated Plan; and

WHEREAS, MTC has dedicated significant resources toward planning efforts that have focused on the transportation needs of low-income, older adult, and disabled residents in the Bay Area; and

WHEREAS, the California Legislature enacted AB 120 Social Service Transportation Improvement Act (Chapter 1120, Statutes of 1979) with the intent to improve transportation service required by social service recipients; and

WHEREAS, under the auspices of the Social Service Transportation Improvement Act, MTC designates agencies to serve as Consolidated Transportation Service Agencies (MTC Resolution 4097, Revised); and

WHEREAS, MTC completed the region's first Coordinated Public Transit-Human Services Transportation Plan in 2007 and updated the plan in 2013 and 2018 (MTC Resolution 4085); and MTC Resolution No. 4680 Page 2

WHEREAS, MTC convened the Blue Ribbon Transit Recovery Task Force to develop the Transit Transformation Action Plan (Action Plan), and the Action Plan was received and accepted by MTC in September 2021; and

WHEREAS, the Action Plan identifies near-term actions, including five accessibilityrelated actions, needed to achieve a more connected, efficient, and user-focused mobility network across the Bay Area and beyond; and

WHEREAS, the 2024 Coordinated Public Transit-Human Services Transportation Plan revises the 2018 Coordinated Plan to include new demographics, transportation service gaps and solutions, and regional context information; and

WHEREAS, the region's Coordinated Plan is integral in identifying key priorities and initiatives for improving and coordinating transit and other transportation services for older adults, people with disabilities, and those with lower incomes through the Regional Network Management Framework (MTC Resolution 4564) and in other initiatives throughout the region and at MTC; now, therefore, be it

RESOLVED, that MTC approves the 2024 Coordinated Public Transit-Human Services Transportation Plan as forth in Attachment A of this resolution, and be it further

<u>RESOLVED</u>, that the Executive Director of MTC is hereby authorized to forward the Coordinated Plan update to the Federal Transit Administration and such agencies as may be appropriate.
