RESOLUTION NO. 4769

WHEREAS, the Metropolitan Transportation Commission (MTC) is the Metropolitan Planning Organization (MPO) and Regional Transportation Planning Agency (RTPA) for the San Francisco Bay Area pursuant to Government Code Section 66500 *et seq.*; and

WHEREAS, the California Public Utilities Commission (CPUC) established the TNC Access for All Program, pursuant to [Senate Bill 1376](#), to improve the availability and accessibility of on-demand transportation services for persons with disabilities, including wheelchair-accessible vehicle (WAV) service; and

WHEREAS, the TNC Access for All program is funded through a \$0.10 surcharge on every TNC trip originating in California and program revenues are returned to the regions in which they are generated and administered locally to support projects that expand accessible, on-demand transportation options; and

WHEREAS, the Metropolitan Transportation Commission (MTC) is an eligible MPO & RTPA and may receive state funding from the TNC Access for All Program to administer a funding program for local Access Providers for on-demand WAV transportation projects; and

WHEREAS, the statutes related to state-funded transit projects require a local or regional administering agency to abide by various regulations; and

WHEREAS, Senate Bill 1376 (2018) designated the CPUC as the administrative agency for the TNC Access for All Program; and

WHEREAS, the CPUC has developed the TNC Access for All Program Overview & Requirements for Access Fund Administrators (AFAs), for the purpose of selecting Local AFAs (LAFAs), and administering and distributing Access Funds to eligible local Access Providers of on-demand WAV transportation; and

WHEREAS, the Metropolitan Transportation Commission authorizes MTC Staff, to execute required documents and any amendments thereto; and

WHEREAS, Metropolitan Transportation Commission wishes to serve as the LAFA for the counties of Marin, Napa, San Mateo, Santa Clara, and Sonoma; now, therefore, be it

RESOLVED, by the Board of Directors of the Metropolitan Transportation Commission that as the Access Fund recipient agrees to comply with all conditions and requirements set forth in the Certification document and applicable statutes, regulations, and Program Requirements for the TNC Access for All Program; and be it further

RESOLVED, that MTC Staff be authorized to execute all required documents of the Program and any amendments thereto with the CPUC; and be it further

RESOLVED, by the Board of Directors of the Metropolitan Transportation Commission that it hereby authorizes the Metropolitan Transportation Commission to serve as the LAFA of the TNC Access for All Program for the counties of Marin, Napa, San Mateo, Santa Clara, and Sonoma.
