

# Plan Bay Area 2050+ Draft Implementation Plan Tables Attachment B

To identify the near-term steps necessary to achieve the Plan Bay Area 2050+ vision, the Implementation Plan focuses on concrete actions that MTC and ABAG can advance in partnership with other organizations by 2030. These implementation actions represent the who, what, where, when and how of making the plan's 35 strategies a reality.

Building upon Plan Bay Area 2050's Implementation Plan, which identified actions to prioritize between 2021 and 2025, this Implementation Plan assesses each strategy under current conditions, updating the timeline to 2026 through 2030. This Implementation Plan aims to be focused, providing an ambitious and *achievable* list of priorities rather than a long wish list. It also aims to be responsive and measurable, identifying new metrics to better track progress.

MTC and ABAG staff have engaged externally and internally over the past year to develop the following 65 draft implementation actions. Feedback was gathered through in-person workshops, an online survey for partners, and a series of internal cross-agency sessions to align the implementation work with other stakeholders' efforts.

Successful implementation of the Plan Bay Area 2050+ strategies will require collaboration with a range of partners including local jurisdictions, community-based organizations (CBOs), transit agencies, and regional partners as well as complementary implementation efforts led by others. To maintain clarity, transparency, and accountability, the Implementation Plan highlights only those efforts that MTC and ABAG are directly involved in, rather than attempting to catalog all activities across the Bay Area. This decision was made to be intentional about where the agencies do and do not have a direct implementation role.

This attachment includes more detailed action descriptions and will be included in an Implementation Plan Supplemental Report which will accompany a more digestible, public-facing version of the Implementation Plan in the Plan Bay Area 2050+ Document, slated to be publicly available on October 20, 2025, at planbayarea.org. The Supplemental report tables have the following columns:

Column 1 (Theme and Strategy): Plan Bay Area Theme and Strategies in each Element to help map implementation actions onto specific Plan Bay Area strategies.

**Column 2 (Implementation Vehicle)**: Implementation actions have been categorized to help describe the nature of implementation. Actions may contain elements of more than one vehicle. The action tables simply list the vehicle that comprises over 50% of the action's substance to describe the majority of agency activities.

- Coordinate: Convene partners and stakeholders to enable collaboration, streamline processes and deliver regionally shared priorities.
- Plan: Analyze past and present dynamics and explore future trends to inform policy, programs and funding decisions.
- Assist: Provide technical assistance and guidance to local jurisdictions, including informational materials, grants, and best practices.
- Advocate: Advocate for plan-aligned policies and funding at federal and state levels by supporting and introducing legislation or amending existing legislation.
- Fund: Pursue or provide plan-aligned funding. This vehicle is often paired with advocacy.
- **Deliver:** Administer MTC/ABAG programs and expand successful pilots.

Column 3 and 4 (Action Number and Draft Implementation Actions): Draft implementation actions include a bolded title as well as bullets providing specificity and detail that may be helpful for technical partners.

Column 5 (Timeline): Timeline indicates whether the action is expected to occur in the first half of the implementation period (Years 1–2), the second half (Years 3–5), or on an ongoing basis.

Column 6 (Role): Agency Role identifies whether MTC/ABAG will lead, partner, or support each action.

In addition to these tables, the Draft Implementation Plan will include accompanying narrative, a look at progress over the past five years, and additional context about the Plan Elements.
