## Introduction

The Metropolitan Transportation Commission (“MTC”) and Association of Bay Area Governments (“ABAG”), acting as Lead Agencies under the California Environmental Quality Act (“CEQA”), prepared the Final Environmental Impact Report (“EIR”) (State Clearinghouse No. 2020090519) for Plan Bay Area 2050 (“the Plan”), which was certified by MTC (MTC Resolution No. 4484) and ABAG (ABAG Resolution No. 08-21) on October 21, 2021.

Since the certification of the Final EIR, the California Department of Transportation (“Caltrans”) District 4 in cooperation with the Sonoma-Marín Area Rail Transit (SMART) and the Sonoma County Transportation Authority (SCTA), propose an amendment to add the cost and description of the SMART rail extension project to the City of Healdsburg (“Amendment”), a new regionally significant project to the Plan. The Amendment will extend SMART passenger rail service northward from the Town of Windsor in Sonoma County to the City of Healdsburg. The project was not included in the Plan’s financially constrained transportation investment strategy and consequently was not assessed in the Final EIR for the Plan.

Accordingly, this Addendum evaluates whether the Amendment could result in additional significant effects on the environment relative to the conclusions reached in the Final EIR for the Plan. This Addendum has been prepared to conform to the requirements of CEQA and CEQA Guidelines §15164.

## Purpose of an Addendum

CEQA Guidelines § 15164(a) provides that the lead agency or a responsible agency shall prepare an addendum to a previously certified EIR or Negative Declaration (“ND”) if some changes or additions are necessary but none of the conditions described in CEQA Guidelines § 15162 calling for preparation of a subsequent EIR or ND have occurred (CEQA Guidelines, § 15164(a)).

An addendum need not be circulated for public review but can be included in or attached to the Final EIR or ND (CEQA Guidelines § 15164(c)). The decision-making body shall consider the addendum with the Final EIR prior to making a decision on the project (CEQA Guidelines § 15164(d)). An agency must also include a brief explanation of the decision not to prepare a subsequent EIR or ND pursuant to § 15162 (CEQA Guidelines § 15164(e)).

Under CEQA Guidelines § 15162, once an EIR or ND has been certified for a project, no subsequent EIR or ND is required under CEQA unless, based on substantial evidence the lead agency determines one or more of the following:

1. substantial changes are proposed in the project which will require major revisions of the previous EIR or ND due to the involvement of new significant environmental effects or a substantial increase in the severity of previously identified significant effects;
2. substantial changes occur with respect to the circumstances under which the project is undertaken which will require major revisions of the previous EIR or ND due to the

involvement of new significant environmental effects or a substantial increase in the severity of previously identified significant effects; or

3. new information of substantial importance, which was not known and could not have been known with the exercise of reasonable diligence at the time the previous EIR was certified as complete or the ND was adopted, shows any of the following:
  - a. the project will have one or more significant effects not discussed in the previous EIR or ND;
  - b. significant effects previously examined will be substantially more severe than shown in the previous EIR;
  - c. mitigation measures or alternatives previously found not to be feasible would in fact be feasible and would substantially reduce one or more significant effects of the project, but the project proponents decline to adopt the mitigation measure or alternative; or
  - d. mitigation measures or alternatives which are considerably different from those analyzed in the previous EIR would substantially reduce one or more significant effects on the environment, but the project proponents decline to adopt the mitigation measure or alternative.

As will be shown herein, the Amendment results in only minor changes to the Plan and Final EIR.

## **Intended Uses of this Addendum**

An addendum to an EIR is an informational document used in the planning and decision-making process. The intent of this Addendum to the Final EIR for the Plan is to provide MTC and ABAG with additional information regarding the potential environmental impacts of the Amendment to the Plan. As will be shown herein, the Amendment results in only minor changes to the Plan and Final EIR.

MTC and ABAG may approve the Amendment based on the analysis provided in this Addendum, which shows that the impacts of the Plan (as amended) remain within the scope of the impacts previously analyzed in the Final EIR (CEQA Guidelines § 15061(b)(3)). The Amendment does not require any revisions to the Final EIR. No new significant information or significant changes in circumstances surrounding the Plan (“the project”) have occurred since the certification of the Final EIR. The previous analysis included in the Final EIR therefore remains adequate under CEQA. However, MTC and ABAG remain obligated to comply with all applicable mitigation measures and conditions of approval contained within the Final EIR.

## **Incorporating by Reference**

In compliance with CEQA Guidelines § 15150, this Addendum has incorporated by reference the Draft and Final EIR for the Plan (SCH No. 2020090519) and all technical studies, analyses, and technical reports that were prepared as part of the Draft and Final EIR or for this Addendum.

Relevant information from documents incorporated by reference into this Addendum have been briefly summarized in the following section, and the relationship between the incorporated part of the referenced document and this Addendum has been described.

## Project Description

This section provides a description of the Plan evaluated in the Final EIR, and the Amendment to the Plan proposed by the Caltrans District 4.

### Overview of Plan Bay Area 2050

Plan Bay Area 2050 is a 30-year plan designed to chart a course to make the Bay Area affordable, connected, diverse, healthy, and vibrant for all residents through 2050 and beyond. It includes thirty-five strategies across four key elements: housing, the economy, transportation, and the environment. These strategies provide a blueprint for future growth, enhance regional equity and resilience, and aim to achieve regional greenhouse gas emission reduction targets set by the California Air Resources Board pursuant to Senate Bill 375. Plan Bay Area 2050 includes supplemental reports for more details. You can find these documents and the adopted final plan at <https://planbayarea.org/finalplan2050>.

MTC and ABAG propose an amendment to Plan Bay Area 2050, revising the transportation element to include the scope and cost of the Sonoma-Marin Area Rail Transit (SMART) passenger rail extension to Healdsburg in Sonoma County.

### Transportation Element

The transportation element of Plan Bay Area 2050 includes 12 strategies with a total investment of \$578 billion, charting the course for the region's roads, highways, bridges, transit, and active transportation infrastructure. The list of projects and programs included in these strategies is fiscally constrained and is documented in the Plan Bay Area 2050 Transportation Project List.

The Plan Bay Area 2050 Transportation Project List categorizes transportation projects into two types: exempt projects and regionally significant capacity-increasing projects. Regionally significant capacity-increasing projects must be included in the regional transportation-air quality conformity determination and be listed with their scopes and costs in the Plan Bay Area 2050 Transportation Project List to progress from concept to construction.

### SMART Healdsburg Extension Project (Sonoma County)

In spring 2024, the California Department of Transportation District 4 requested an amendment to Plan Bay Area 2050. The request was to add to the Plan Bay Area 2050 Transportation Project List a new regionally significant project to extend SMART passenger rail service northward from the Town of Windsor in Sonoma County.

The increased costs for the SMART rail extension project to the City of Healdsburg will be offset by equivalent reductions in the costs and scope of other Sonoma County projects and programs in the plan's fiscally constrained transportation project list. No additional funds are being added to

the transportation revenue forecast. As a result, the plan remains fiscally constrained as required by federal and state planning laws. Table 1 below details the revisions to the Plan Bay Area 2050 Transportation Project List.

The changes reflected in this amendment, as reflected in Table 1, have been incorporated into the latest planning assumptions for regionally significant capacity-increasing projects, as reflected in the regional emissions analysis for the Draft Transportation-Air Quality Conformity Analysis for the Amended Plan Bay Area 2050 and 2025 Transportation Improvement Program, released on August 12, 2024.

No other changes or revisions are proposed with this amendment.

# CEQA Checklist and Impact Analysis

## Scope of Analysis

This Addendum evaluates whether the Amendment to the Plan could result in additional significant effects on the environment relative to the conclusions reached in the Final EIR for the Plan.

This Addendum relies on the significance criteria for each issue area and the corresponding analysis methodology described in the Final EIR to assess the potential impacts of the Amendment.

The following environmental categories were specifically examined to determine whether the Amendment would have an effect on the analysis in the Final EIR:

- Aesthetics and Visual Resources
- Agriculture and Forestry Resources
- Air Quality
- Biological Resources
- Climate Change, Greenhouse Gases, and Energy
- Cultural Resources and Tribal Cultural Resources
- Geology, Seismicity, and Mineral Resources
- Hazards and Wildfire
- Hydrology and Water Quality
- Land Use, Population, and Housing
- Noise
- Public Services and Recreation
- Public Utilities and Facilities
- Transportation

## Analysis

Additional analysis has been conducted for the environmental categories listed above and the results are discussed below in Table 1. As evidenced herein, the Amendment results in no substantial changes to the Plan (“the project”) nor does the Amendment result in substantial changes with respect to the circumstances under which the Plan is undertaken. The Amendment does not require major revisions of the Final EIR, or preparation of a new, subsequent or supplemental EIR, due to the involvement of new significant environmental effects or a substantial increase in the severity of previously identified significant effects. As evidenced herein, the Plan (as amended) would not result in any new impacts that were not previously disclosed, nor has the environmental baseline in the Bay Area changed since the Final EIR, such that new impacts would be created. This conclusion for each environmental topic is explained in the column labeled “Substantial Increase in the Severity of Previously Disclosed Significant Effects.” No new or revised mitigation measures are necessary as a result of the Amendment. All mitigation measures adopted in the Final EIR continue to remain in effect and are incorporated by reference in this Addendum.

## Technical Revisions

Technical revisions have been made to key tables in the Final EIR, specifically within the sections addressing Air Quality; Climate Change, Greenhouse Gases, and Energy; and Transportation. These revisions reflect the incorporation of the Amendment to Plan Bay Area 2050 (the “Amendment”), as detailed below. The updated data informed the analysis in Table 1. ### Air Quality

Several tables included in the Air Quality section (Section 3.4) of the Draft/Final EIR have been revised to reflect changes resulting from the Amendment, as well as to incorporate Final EIR data where applicable. The revised tables are presented below.

Tables 3 and 4 contain updated emission estimates for criteria pollutants resulting from the Amendment, which were used to inform Impact AQ-3 in the Final EIR. The Final EIR concluded that the Plan would result in net increase in particulate matter (PM) emissions, thereby finding that the Plan could cause a net increase in criteria pollutants for which the region is in non-attainment. The Amendment results in a slight decrease in net mobile emissions of ROG and NOX, but a slight increase in PM10 emissions. However, these changes do not affect the significance conclusions made in the Final EIR.

Table 5 presents mobile source emission estimates for toxic air contaminants used to inform the analysis for Impact AQ-4 in the Final EIR. The Final EIR concluded that the Plan could expose sensitive receptors to substantial pollutant concentrations. The Amendment results in a slight increase in diesel particulate matter emissions, but this does not alter the significance conclusions made in the Final EIR.

As discussed in Table 1, and shown above in Tables 2 through 5, the Amendment results in negligible differences relative to the Final EIR; however, the Amendment does not result in any changes to the significance conclusions relative to the impacts analyzed in the Final EIR. There would be no new significant impacts related to air quality from the Amendment to the Plan, nor would the severity of any previously identified significant impacts increase. Furthermore, the revised data shown above is very similar to the findings of the Final EIR. The Amendment would also incorporate the same mitigation measures identified in the Final EIR, as applicable.

## Climate Change, Greenhouse Gases, and Energy

Several tables included in the Climate Change, Greenhouse Gases, and Energy section (Section 3.6) of the Draft/Final EIR have been revised to reflect changes resulting from the Amendment, as well as to incorporate Final EIR data where applicable. The revised tables are presented below.

Tables 7 and 8 contain updated annual estimates of greenhouse gas (GHG) emissions, used to inform the analysis for Impact GHG-1 in the Final EIR. The Final EIR concluded that the Plan would result in a net reduction in transportation-related GHG emissions by 2050, but an increase in land use-related GHG emissions. As a result, the Final EIR found that the Plan could cause a net increase of greenhouse gas emissions. While the Amendment further reduces mobile-source GHG emissions, it does not affect the land-use related GHG emissions or the significance conclusions made in the Final EIR.

Table 9 (Revised EIR Table 3.6-15) provides the SB 375 target analysis of passenger vehicle and light duty truck CO<sub>2</sub> emissions as a result of the Amendment. Impact GHG-2 in the Final EIR found that the Plan would reduce per-capita emissions by over 19 percent by 2035 as compared to 2005 levels, resulting in a less-than-significant (LS) impact. The Amendment does not alter the reduction in per capita CO<sub>2</sub> emissions compared to the Final EIR.

Table 10 calculates GHG reductions relative to 1990 and 2015 levels for analyzing Impact GHG-3 in the Final EIR. The Final EIR found that additional reductions would be necessary to meet the state’s 2050 GHG goals, resulting in a significant impact. The Amendment slightly reduces the required GHG reductions, but the impact remains significant.

As discussed in Table 1, and shown above in Tables 6 through 10, the Amendment results in negligible differences relative to the Final EIR; however, the Amendment does not result in any changes to the significance conclusions relative to the impacts analyzed in the Final EIR. There would be no new significant impacts related to climate change, greenhouse gases or energy from the Amendment to the Plan, nor would the severity of any previously identified significant impacts increase. Furthermore, the revised data shown above is very similar to the findings of the Final EIR. The Amendment would also incorporate the same mitigation measures identified in the Final EIR, as applicable.

## Transportation

Several tables included in the Transportation section (Section 3.15) of the Draft/Final EIR have been revised to reflect changes resulting from the Amendment, as well as to incorporate Final EIR data where applicable. The revised tables are presented below.

Tables 11 and 12 show revised travel activity forecasts used to inform the analysis of Impact TRA-2 in the Final EIR. The Amendment has a negligible effect on daily vehicle miles traveled (VMT) and vehicle trips but does not change the forecasts for daily per-capita VMT. The Final EIR concluded that the Plan's comprehensive land use, transportation, and environmental strategies would result in regional per-capita VMT reductions. However, due to the gap between GHG reductions achievable through SB 375 targets and the broader state climate goals, and the fact that many of the VMT reduction strategies can

only be implemented at the local jurisdictional level, the Final EIR could not conclude that the reductions would be sufficient to meet the State's climate goals.

As discussed in Table 1, and shown above in Tables 11 through 12, the Amendment results in negligible differences relative to the Final EIR; however, the Amendment does not result in any changes to the significance conclusions relative to the impacts analyzed in the Final EIR. There would be no new significant impacts related to transportation from the Amendment to the Plan, nor would the severity of any previously identified significant impacts increase. Furthermore, the revised data shown above is very similar to the findings of the Final EIR. The Amendment would also incorporate the same mitigation measures identified in the Final EIR, as applicable.

## Conclusion

The addition of the Amendment to the Plan would not result in any new significant environmental effects or substantial increases in the severity of the previously identified significant effects disclosed in the Final EIR completed for the Plan.

None of the conditions described in §15162 of the CEQA Guidelines requiring the preparation of a subsequent Final EIR have occurred. Therefore, this Addendum to the Final EIR is an appropriate level of environmental review for the Amendment to the Plan as identified in §15164 of the CEQA Guidelines.
