# AUTHORIZATION TO PURSUE A NEW ORGANIZATIONAL PARTNER AND FISCAL AGENT

WHEREAS, at the April 26, 2024 Board meeting the Board identified the need to specifically pursue advocacy, outreach and fundraising responsibilities of a 501(c)3; and

**WHEREAS**, at the April 2024 Board meeting an Ad Hoc Committee was established to work with MTC and the Potrero Group on organizational solutions for the nonprofit; and

**WHEREAS**, the Ad Hoc Committee Chair and Vice Chair met with the Potrero Group and MTC during Summer and Fall 2024 to discuss potential new organizational partnerships; and

**WHEREAS**, the Potrero Group developed concept paper that states that the most viable solution is becoming a project embedded in another Nonprofit; and

WHEREAS, the Ad Hoc Committee supports the pursuit of moving the Bay Trail Project to a new nonprofit partner and fiscal agent in order to best achieve the goals of the functioning 501(c)3; and

WHEREAS, the Bay Trail Nonprofit administrative and related services for the purposes of carrying out its 501(C)3 responsibilities will be provided under a new agreement with a new organizational partner; and

WHEREAS, MTC staff are proposing that MTC/ABAG dissolve the staffing agreement to support the San Francisco Bay Trail Project Nonprofit.
