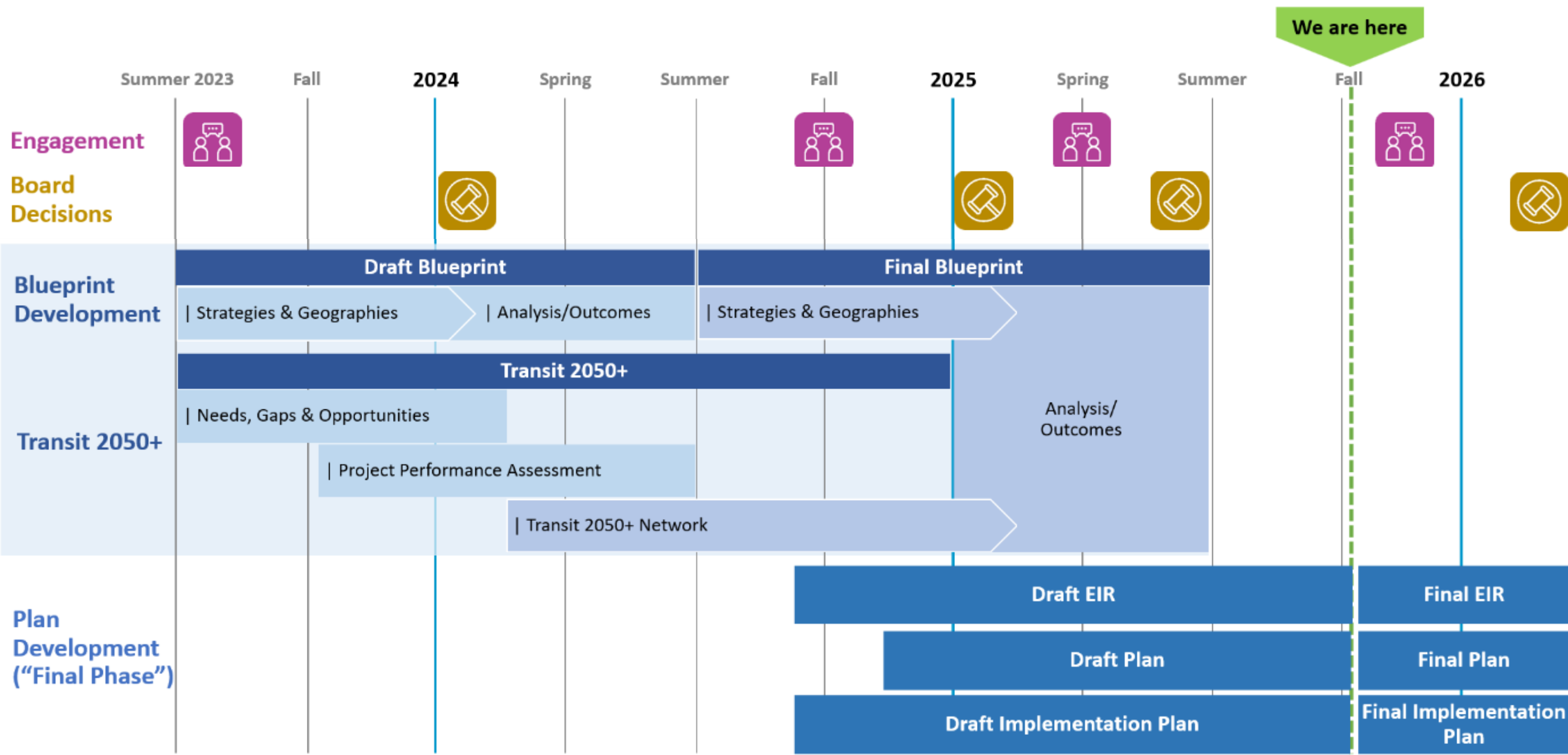

Refresher: The Evolution of Plan Bay Area

Following the enactment of Senate Bill 375 in 2008, successive iterations of the Bay Area's long-range plan have adapted to meet changing needs.



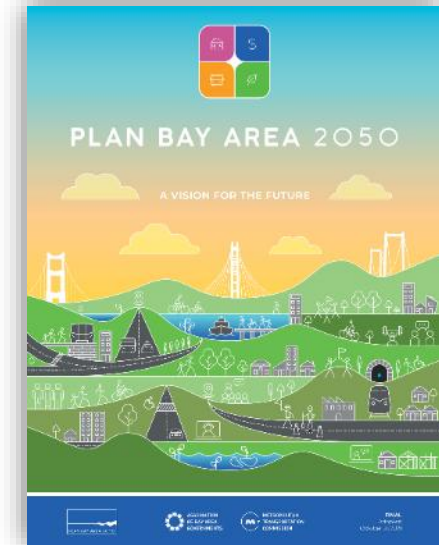
Plan Bay Area (2013)

- Integrated **climate, transportation and land use**
- Established a shared regional emphasis on **sustainability**



Plan Bay Area 2040 (2017)

- Highlighted the **regional housing crisis**, launched the CASA process and identified the “3Ps” approach
- Emphasized **inequality and disaster vulnerability**



Plan Bay Area 2050 (2021)

- Included four expansive **elements and 35 strategies**, quantification of strategy costs, and a detailed **Implementation Plan**
- Emphasized **resilience and equity**

Refresher: Plan Bay Area 2050+ Key Focus Areas



Navigating Post-Pandemic Realities

- Tackled **remote work's** impact on travel behavior
- Responded to **transit ridership** declines
- Addressed **rising office vacancies** and land use shifts



Planning Amid Financial Constraints

- Adjusted to an **\$80 billion reduction** in anticipated transportation revenues
- Recalibrated housing strategies to drive a **20+% reduction** in per-unit affordable housing construction costs



Reimagining Transit

- Launched **Transit 2050+** with a **collaborative co-management** model
- Prioritized **safety, frequency, and rider focused** improvements
- Advanced a more **unified regional transit network**



Elevating Resilience and Balancing Climate Goals

- Introduced the first-ever **Sea Level Rise Resilience Project List**, in collaboration with BCDC
- Implemented cost-effective solutions to achieve the plan's **aggressive, statutorily-required climate target**

Draft Plan Bay Area 2050+: Release

On October 20, 2025, MTC & ABAG released the Draft Plan Bay Area 2050+ for public review and comment, marking one of the most significant milestones in the nearly three-year planning process.



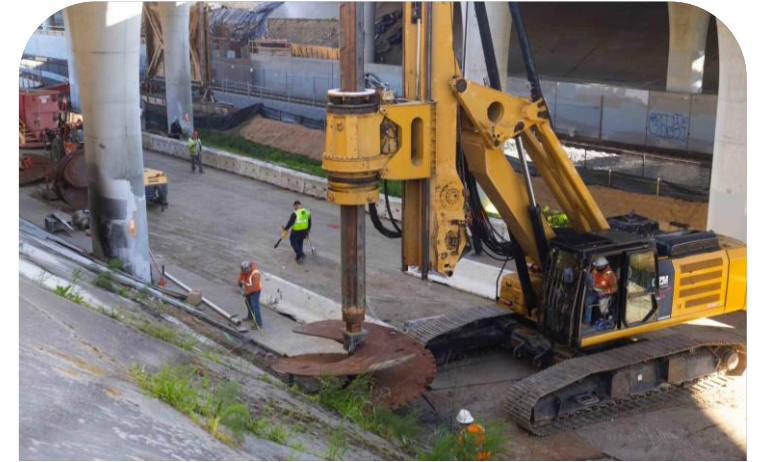
Draft Plan Document

The Plan Bay Area 2050+ document is the primary public-facing product of the long-range planning process.



Draft Environmental Impact Report

Under CEQA, California MPOs are required to prepare a programmatic EIR for regional long-range plans.



Draft Implementation Plan ★

The Implementation Plan identifies near-term actions MTC & ABAG can take to advance the long-range strategies in the plan.

The plan document includes the following components:

- Introduction to the regional **post-pandemic context** and a refresher on progress towards long-range goals
- High-level **orientation to the plan**
- Overview of key **planning assumptions**
- Refinements to 25-year **plan strategies**
- **Anticipated outcomes** if strategies are implemented
- **60+ near-term implementation actions**

An additional **10 supplemental reports** offer further details and context on specific subject areas addressed by the plan, while fulfilling federal & state requirements.



PLAN BAY AREA 2050 +



The Draft EIR includes the following components:

- Overview of the Draft Plan's **purpose, objectives, and regional growth pattern**, plus key resilience and transportation investments
- Evaluation of **environmental impacts** across 14 topic areas (e.g., transportation, air quality, greenhouse gases, biological resources)
- Summary of analytical methods, **potential impacts, mitigation strategies, and significance conclusions**
- Comparison of the Draft Plan to **three alternatives**: No Project, Transit Reinvestment, and TOC Growth Focus
- Analysis of **cumulative, growth-inducing, and irreversible impacts** associated with the Draft Plan



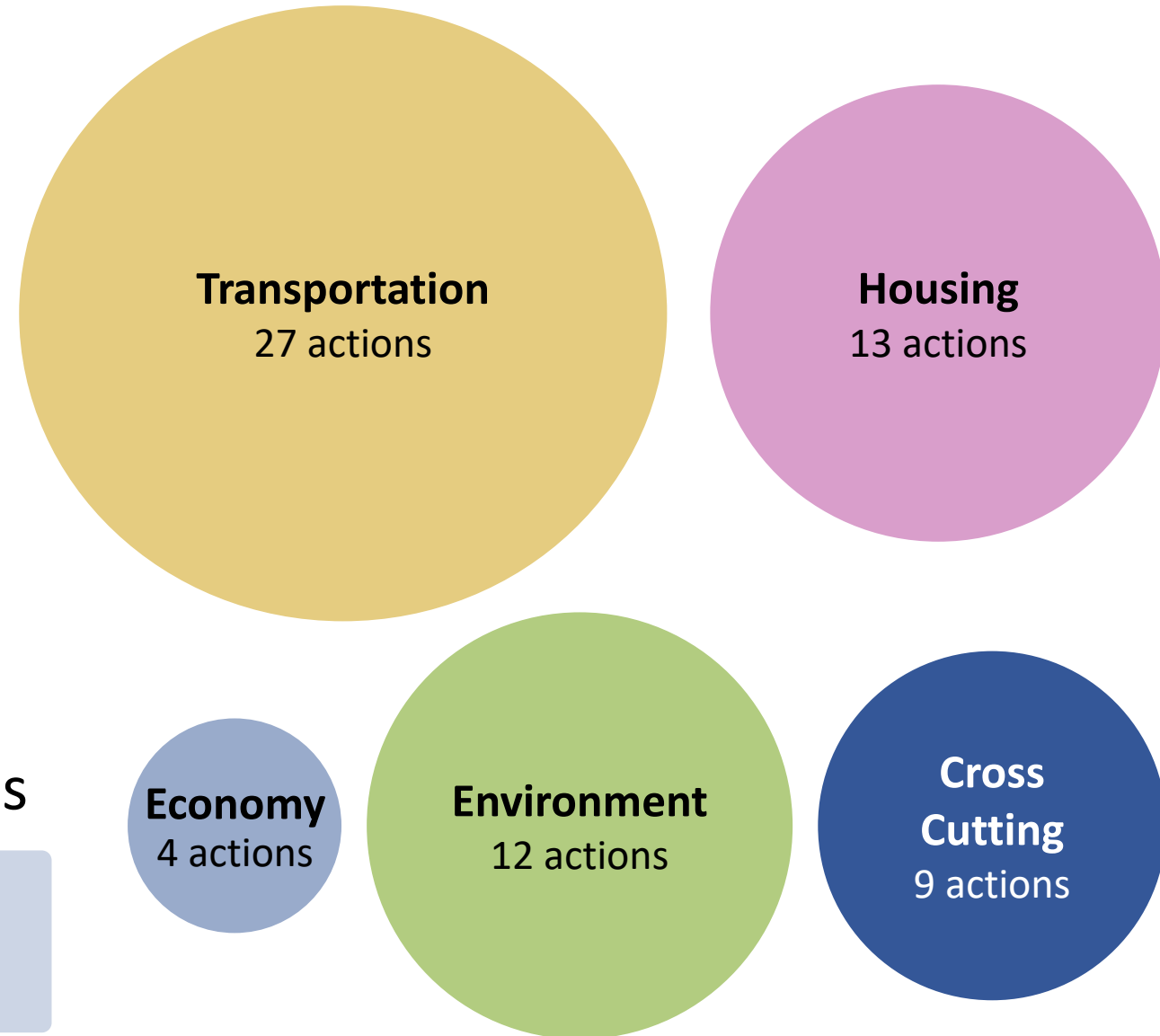
Draft Implementation Plan: Summary and Key Priorities

The **Draft Implementation Plan** includes **65 actions** organized across six vehicles: *Plan, Fund, Coordinate, Advocate, Deliver* and *Assist*.

Key Priorities for 2026 through 2030:

1. Deliver existing commitments
2. Transition successful pilots into ongoing initiatives
3. Secure resources to sustain progress

The **Implementation Plan Supplemental Report** builds on content in the Draft Plan Document, providing additional descriptions, sub-actions, and timeframes for completion.



Note: The Implementation Plan is the most dynamic part of the plan's final phase, with significant opportunity to revise draft actions.

- ☐ Prepare for a new regional transportation revenue measure for 2026 and beyond
- ☐ Advance MTC's priorities in the next federal surface transportation reauthorization
- ☐ Identify and pursue other diverse funding sources to accelerate transportation system enhancements

DELIVER & COORDINATE

- ☐ Expand Clipper BayPass and regional wayfinding programs
- ☐ Advance Regional Transit Priority initiatives
- ☐ Improve the efficiency and cost-effectiveness of transportation project delivery with partners
- ☐ Expand and align affordability and equity programs

ASSIST & PLAN

- ☐ Update how MTC works with partners to manage congestion, including reviewing the approach for future Express Lanes
- ☐ Improve street safety and expand active transportation through a package of technical assistance offerings
- ☐ Update the Major Project Advancement Policy

FUND

- ❑ Coordinate with local, regional and state partners on potential near-term ballot measure(s) to expand affordable housing funding
- ❑ Pursue near-term funding to sustain existing regional housing programs and respond to local needs

DELIVER & ASSIST

- ❑ Sustain, enhance and expand the Doorway Housing Portal to help residents find affordable housing
- ❑ Support local jurisdictions with Housing Element implementation and prepare for the next RHNA
- ❑ Implement and monitor Transit-Oriented Communities (TOC) policy to foster transit-supportive development and quality design

PLAN

- ❑ Update the regional goods movement plan, while integrating industrial land use considerations
- ❑ Determine how best to incorporate economic priorities into Plan Bay Area 2060 in alignment with MTC-ABAG core responsibilities

ASSIST

- ☐ Expand planning, funding and project delivery technical assistance for sea level rise adaptation
- ☐ Help jurisdictions adopt stronger seismic and wildfire safety policies and programs
- ☐ Assess and optimize transportation demand management (TDM) initiatives

DELIVER

- ☐ Enhance BayREN's building energy efficiency and resilience programs for residential and commercial renters and property owners, including local governments
- ☐ Pilot methods to accelerate conservation and transportation project delivery

- ☐ Support local efforts to expand electric mobility options
- ☐ Track and coordinate electrification working groups to address common grid barriers

- ❑ Advocate for continued state Regional Early Action Planning (REAP) funding
- ❑ Support reforms to SB 375 and related state planning guidelines to improve cross-government collaboration toward shared climate goals

- ❑ Develop technical assistance that is easy to find, clearly presented, and tailored to local priorities
- ❑ Increase engagement with the disability community to collaboratively and comprehensively meet needs

PLAN & DELIVER

- ❑ Analyze post-COVID shifts in travel, remote work, and land use patterns
- ❑ Update the Regional Growth Framework to support local implementation and better align with regional goals + investments
- ❑ Build and maintain robust regional databases to support models, maps, and analytics

Cross Cutting: Accessibility-Related Actions

COORDINATE

- ❑ Streamline and improve paratransit services and fixed-route transit to enhance access and mobility for seniors and people with disabilities
- ❑ Partner with organizations that promote disability-inclusive design to raise awareness of disability standards

COORDINATE

- ❑ Increase engagement with the disability community to collaboratively and comprehensively meet needs
- ❑ Establish ongoing forums and partnerships to include the voices and leadership of people with disabilities in planning.

ASSIST

- ❑ Provide best practice guidance and training on All Ages and Abilities design guidelines, and Public Right-of-Way Accessibility Guidelines (PROWAG)
- ❑ Strengthen regional support for planning, design and implementation of All Ages and Abilities and PROWAG projects

Regional Tools for Local Action

The Implementation Plan will help guide MTC-ABAG's future planning, funding and coordinating efforts. Plan Bay Area 2050+ also informs tools and resources that help local jurisdictions and partners deliver progress on shared local and regional priorities.



Planning Tools

- Growth Geographies and equity mapping layers
- Regional population, jobs and housing forecasts
- Planning guidelines and Open Data portal



Support for Funding and Grants

- Advances transportation projects to funding and construction phases
- State grant eligibility checklists and advocacy tools
- Financial forecasts for transportation, housing, environment



Implementation and Technical Assistance

- Redevelopment, mobility hubs, parking playbooks
- Technical assistance for transportation and housing

As a reminder, Plan Bay Area does not:

- Allocate money to projects or strategies
- Override local land use authority
- Impose mandates
- Propose specific legislation

Fall 2025:

- Conclude final engagement round and comment period

Winter 2026:

- Review comments and prepare revisions to Draft Plan and Draft EIR
- Present the Final Plan Bay Area 2050+ for adoption and the Final Plan EIR for certification by MTC and ABAG

STATE AND FEDERAL APPROVAL OF FINAL PLAN

- ❑ **CARB Oversight:** CARB retains final approval over the plan's GHG methodologies and assumptions.
- ❑ **Federal Conformity Requirements:** The June 2025 rescission of California's vehicle emissions waiver has triggered a statewide air quality conformity "lockdown," which could potentially delay federal approvals.
- ❑ **Collaborative Response:** Staff are working to address CARB questions on GHG assumptions, strategies, and progress; MTC is working with regional and state partners to minimize conformity lockdown impacts, with ultimate resolution dependent on EPA and CARB agreement.

COMING IN 2026: PLAN BAY AREA 2060

- ❑ **Major Plan Update:** In mid-2026 MTC and ABAG intend to kick-off Plan Bay Area 2060, which will include both "blue sky" and scenario planning for the region.
- ❑ **Different Futures, Urgent Questions:** This effort will allow the agencies to explore varying policy and funding trajectories while investigating many exciting and compelling topics, including:
 - Artificial intelligence
 - Automated vehicles (AVs)
 - Shifting demographics
 - And much more.
