Transportation-Air Quality Conformity Analysis for the 2025 TIP	While preparing the conformity analysis for the PBA2050 SMART extension amendment, formatting errors were discovered in the EMFAC2021 speed bin tables. These errors led to the omission of emission calculations for several passenger vehicle types, resulting in incorrect results. These formatting errors were corrected with technical revisions. The most significant differences appear in wintertime emissions (PM2.5 and wintertime NOX), while summertime ozone pollutants (VOC and summertime NOX) show similar but less pronounced changes. Despite the discrepancies in PM2.5, the analysis still indicates that 94% of the allowable emissions remain. The findings show that the revised analysis, incorporating these technical corrections, indicates forecasted motor vehicle emissions budgets for VOC and NOX. This also applies to PM2.5 and NOX, where the revised emissions, although higher than the draft figures, are still lower than the baseline year scenario. These technical revisions are non-material. While the changes affect the emissions results, they do not significantly alter the overall emissions estimates, the conformity determination, or compliance with air quality standards. The region remains well below the thresholds, so these revisions do not meaningfully impact the emissions estimates or the conclusions of the draft 2025 TIP analysis.
