Contract Amendment – Alta Planning & Design, Inc. for Regional Trails Geographical Information System (GIS) Data Maintenance Dated November 1, 2023 (\$400,000)

Subject:

Request to increase the Maximum Payment for the Regional Trails GIS Data Maintenance Contract Dated November 1, 2023, with Alta Planning & Design, Inc. (Alta) from \$200,000.00 to \$400,000.00. This Contract is the result of a direct select from the 2020 Quick-Build Design and Engineering and Construction Management Services Bench.

As part of the Regional Trails Program, MTC manages the GIS and spatial data for the Bay Trail

Background:

and Regional Connector Trails that provide access to the Bay Trail. MTC required the services of a professional consultant firm to assist with ArcGIS maintenance and support for Regional Trails and specifically the Bay Trail and the Bay Area Trails Collaborative (BATC) network.

In October 2023, Alta was selected through a Direct Select Memorandum from the 2020 Quick-Build Design and Engineering and Construction Management Services—Cycle 1 Bench ("Bench") to perform the Regional Trails GIS Maintenance ("Project"). Firms on the Bench in Service Category A, Design & Engineering were deemed eligible for the Project. The Bench was renewed on June 23, 2023, and extended from June 30, 2023, to February 20, 2025. Service Category A included 11 firms, as shown in Attachment A, List of Firms and Service Categories. Staff recommended the direct selection of Alta for the Project. Alta is the only eligible firm with qualifications in regional trail planning, geospatial analysis and quick build project delivery for Bay Trail, and has extensive experience working on MTC projects that bridge spatial analytics and prioritization for implementation, such as the MTC Active Transportation Origin-Destination Study and the Bay Trail Gap Closure Implementation Plan. The other firms on the bench did not have the same level of expertise or experience to complete this project as they do

In November 2023, Alta was awarded a \$178,710 contract for the Project. In February 2024, the contract was amended to increase the maximum payment by \$21,290 to \$200,000 by executive

not historically have experience with the nine-county Bay Trail spatial network.

authority. Alta performs a unique combination of GIS maintenance, hosting, coordination, customer service and updates to the Bay Trail Interactive Map and Data and the BATC Data. The scope of work to be completed under the proposed contract amendment includes ongoing GIS maintenance, hosting, coordination, customer service and updates to the Bay Trail and BATC Data through November 30, 2025. This work is critical to completing and maintaining updated trail datasets that are used by MTC, partner agencies throughout the Bay Area region, and by the public.

The Project is funded with non-federal BATA Transit Transfer Fiscal Year (FY) 2024-2025 funds. Funding was approved in the final FY 2024-2025 MTC Budget Amendment 1. This program is not essential to regulatory, statutory, or legal requirements and is not dependent on any subsequent phases in FY 2024-2025. Alta is neither a small business nor a disadvantaged business enterprise and has no subcontractors, as shown in Attachment B.

Recommendations:

Staff recommends the MTC Planning Committee authorize the Executive Director or designee to negotiate and enter into a contract amendment with Alta Planning & Design, Inc. to provide Quick-Build Design and Engineering Services for Regional Trails GIS Maintenance in an amount not to exceed \$400,000.
