ABSTRACT

Resolution No. 4717, Revised

This resolution approves the allocation of fiscal year 2025-2026 Senate Bill 125 funds, including those from the Transit and Intercity Rail Capital Program (TIRCP) and the Zero-Emission Transit Capital Program (ZETCP), to claimants in the MTC region.

This resolution allocates funds to the San Francisco Bay Area Rapid Transit District (BART).

Attachment A was revised on July 23, 2025 to allocate funds to the San Joaquin Regional Rail Commission.

Attachment A was revised on September 24, 2025 to allocate funds to the Golden Gate Bridge, Highway, and Transit District (GGBHTD).

Attachment A was revised on October 22, 2025 to allocate funds to San Francisco Municipal Transportation Agency (SFMTA).

Attachment A was revised on November 19, 2025 to allocate funds to the Peninsula Corridor Joint Powers Board (Caltrain).

RESOLUTION NO. 4717

WHEREAS, pursuant to Government Code Section 66500 et seq., the Metropolitan Transportation Commission (“MTC”) is the regional transportation planning agency for the San Francisco Bay Area; and

WHEREAS, Senate Bill (SB) 125 (Chapter 54, Statutes of 2023) guides the distribution of funding from the Transit and Intercity Rail Capital Program (TIRCP) and the Zero-Emission Transit Capital Program (ZETCP) to regional transportation planning agencies, which will have the flexibility to use the money to fund transit operations or capital improvements; and

WHEREAS, TIRCP is comprised of funds from either the state of California General Fund (GF) or the Greenhouse Gas Reduction Fund (GGRF); and

WHEREAS, ZETCP is comprised of funds from either the Public Transportation Account (PTA) or the Greenhouse Gas Reduction Fund (GGRF); and

WHEREAS, MTC is the regional transportation planning agency responsible for the allocation of SB 125 funds to eligible claimants within the MTC region; and

WHEREAS, MTC Resolution No. 4619, Revised identifies standardized operating shortfalls for transit agencies serving the MTC region through FY2025-26; and

WHEREAS, claimants in the MTC region have submitted claims for the allocation of fiscal year 2025-26 SB 125 funds that are no greater than the standardized shortfalls identified in MTC Resolution No. 4619, Revised, less the regional funding contribution attributed to that operator for the fiscal year in question; and

WHEREAS, Attachment A to this resolution, attached hereto and incorporated herein as though set forth at length, lists the amounts of and purposes for the fiscal year 2025-26 allocations requested by claimants, and is from time-to-time revised; and

WHEREAS, this resolution, including the revisions to Attachment A and the sum of all allocations made under this resolution, are recorded and maintained electronically by MTC; and

WHEREAS, the claimants to which funds are allocated under this resolution have submitted updates on the status of the SB 125 Regional Accountability Measures assigned to them under MTC Resolution No. 4619, Revised, therefore, be it

RESOLVED, that MTC finds the claimants have made sufficient progress toward the assigned SB 125 Regional Accountability Measures; and, be it further

RESOLVED, that MTC approves the allocation of fiscal year 2025-26 SB 125 funds to the claimants, in the amounts, for the purposes, and subject to the conditions, as listed and recorded on Attachment A to this resolution.
