Contract Amendment – Interstate-880 (I-880) Integrated Corridor Management (ICM) North Segment Construction Management Services: MNS Engineers, Inc. (\$23,000)

Subject:

Contract Amendment – I-880 ICM North Segment Construction Management Services: MNS Engineers, Inc. (\$23,000).

Background:

The I-880 ICM North Segment Project is a collaborative effort led by MTC, with California Department of Transportation (Caltrans) District 4, City of Oakland, City of San Leandro, and Alameda-Contra Costa Transit District (AC Transit). The project aims to minimize the burden on local streets of incidents occurring along I-880 by installing Intelligent Transportation System (ITS) equipment on key arterial streets to redirect motorists safely and efficiently back onto I-880. Stakeholders identified this project for deployment as part of an overall ICM approach to improve mobility, accessibility, and safety along the I-880 corridor.

The project is in the final system integration phase, which includes coordinating systems that jointly operate ITS infrastructure installed on arterial streets by the project (e.g., closed circuit television cameras, electronic message signs). The project also includes traffic signal intersection upgrades such as curb ramps, detectors, signal coordination, and communications.

In November 2017, following a competitive Request for Qualifications (RFQ) process, the MTC Operations Committee approved a contract with S&C Engineers, Inc. (now MNS Engineers, Inc.) to provide overall project and construction management, oversee and facilitate the timely and efficient completion of work by both the civil construction contractor and system integrator, and proactively lead stakeholder coordination. Following negotiations, a contract was executed for \$1,698,639. The original period of performance was through June 30, 2020; the period of performance has since been extended through June 30, 2025 to align with construction and system integration schedules, which were extended due to delayed responses by utilities and local agencies, COVID, and other delays caused by the contractor. In July 2020 the Operations Committee approved an additional \$456,000 for continued support through expected completion

dates at that time, and in September 2021 the Operations Committee approved an additional \$334,000 for support through construction completion. Civil construction was completed in August 2022 and completion of system integration is now expected in early 2025.

This amendment would add up to \$23,000 for construction management support during the remainder of the system integration phase and for project closeout support. Support provided by MNS Engineers, Inc. to date has been completed within budget; additional funds are needed because system integration completion dates have been extended due to local agency delays in deploying key system upgrades and completion of necessary system enhancements. Additional time is needed for MNS to provide key oversight and coordination of final system integration tasks, including ensuring compatibility of recently upgraded systems with the I-880 ICM system, reviewing final system documentation, and supporting project closeout.

Attachment A includes a summary of MNS Engineers, Inc.'s and its project team's small business and disadvantaged business enterprise status.

Staff recommends that this Committee authorize the Executive Director or designee to negotiate and enter into a contract amendment with MNS Engineers, Inc. to provide Construction Management Services, in an amount not to exceed \$23,000.
