BAIFA Resolution No. 48 - I-80 Express Lanes in Solano County (I-80 Solano Toll System)
Regional Measure 3 (RM3) Allocation Request

#### **Subject:**

A request for approval of BAIFA Resolution No. 48, Regional Measure 3 (RM3) Allocation Request for I-80 Express Lanes in Solano County (I-80 Solano Toll System) project.

#### **Background:**

The I-80 Solano Toll System project will be delivered by BAIFA in coordination with the I-80 Express Lanes in Solano County Civil project, being delivered by Solano Transportation Authority and Caltrans. Together the two projects comprise the Solano I-80 Managed Lanes project currently under construction between Red Top Road and I-505.

In Fall 2020, the California Transportation Commission (CTC) programmed over \$123 million in Senate Bill 1 (SB1) Trade Corridor Enhancement Program (TCEP) funds for the Solano I-80 Managed Lanes project. MTC programmed matching funds from the RM3 Express Lanes Program in May 2020 via MTC Resolution No. 4411. With the recent resolution of litigation related to RM3, the Bay Area Toll Authority released the toll funds that were held in escrow during litigation and is making RM3 allocations.

In April 2021, MTC approved a Letter of No Prejudice (LONP) to BAIFA for \$31,276,000 for the I-80 Solano Toll System project under MTC Resolution No. 4412, Revised. In July 2021, MTC approved Resolution No. 4480, which allocated \$2,822,000 in Core Capacity Challenge Grant Program Toll Savings (CCCGP) to BAIFA for the project. The CCCGP funds were originally intended for an AC Transit project, which instead received federal funds earmarked for the I-80 Solano Toll System project. This \$2,822,000 amount is intended as repayment from AC Transit for advanced federal funds.

BAIFA is now requesting approval of an RM3 allocation of \$31,276,000 for the I-80 Solano Toll System project, and staff seeks BAIFA approval of the allocation request made to MTC.

## BAY AREA INFRASTRUCTURE FINANCING AUTHORITY RESOLUTION NO. 48

WHEREAS, SB 595 (Chapter 650, Statutes 2017), commonly referred as Regional Measure 3, identified projects eligible to receive funding under the Regional Measure 3 Expenditure Plan; and

WHEREAS, the Metropolitan Transportation Commission (MTC) is responsible for funding projects eligible for Regional Measure 3 funds, pursuant to Streets and Highways Code Section 30914.7(a) and (c); and

WHEREAS, MTC has established a process whereby eligible transportation project sponsors may submit allocation requests for Regional Measure 3 funding; and

WHEREAS, allocation requests to MTC must be submitted consistent with procedures and conditions as outlined in Regional Measure 3 Policies and Procedures (MTC Resolution No. 4404; and

WHEREAS, the Bay Area Infrastructure Financing Authority (BAIFA) is an eligible sponsor of transportation project(s) in the Regional Measure 3 Expenditure Plan; and

WHEREAS, the I-80 Express Lanes in Solano County (I-80 Solano Toll System) project is eligible for consideration in the Regional Measure 3 Expenditure Plan, as identified in California Streets and Highways Code Section 30914.7(a); and

WHEREAS, the Regional Measure 3 allocation request, attached hereto in the Initial Project Report and incorporated herein as though set forth at length, lists the project, purpose, schedule, budget, expenditure and cash flow plan for which BAIFA is requesting that MTC allocate Regional Measure 3 funds; now, therefore, be it

RESOLVED, that BAIFA, and its agents shall comply with the provisions of the Metropolitan Transportation Commission's Regional Measure 3 Policies and Procedures); and be it further

RESOLVED, that BAIFA certifies that the project is consistent with the Regional Transportation Plan (RTP); and be it further

RESOLVED, that the year of funding for any design, right-of-way and/or construction phases has taken into consideration the time necessary to obtain environmental clearance and permitting approval for the project; and be it further

RESOLVED, that the Regional Measure 3 phase or segment is fully funded, and results in an operable and useable segment; and be it further

RESOLVED, that BAIFA approves the allocation request and updated Initial Project Report, attached to this resolution; and be it further

RESOLVED, that BAIFA approves the cash flow plan, attached to this resolution; and be it further

RESOLVED, that BAIFA has reviewed the project needs and has adequate staffing resources to deliver and complete the project within the schedule set forth in the allocation request and updated Initial Project Report, attached to this resolution; and, be it further

RESOLVED, that BAIFA is an eligible sponsor of projects in the Regional Measure 3 Expenditure Plan, in accordance with California Streets and Highways Code 30914.7(a); and be it further

RESOLVED, that BAIFA is authorized to submit an application for Regional Measure 3 funds for I-80 Express Lanes in Solano County (I-80 Solano Toll System) project in accordance with California Streets and Highways Code 30914.7(a); and be it further

RESOLVED, that BAIFA certifies that the projects and purposes for which RM3 funds are being requested is in compliance with the requirements of the California Environmental Quality Act (Public Resources Code Section 21000 et seq.), and with the State Environmental Impact Report Guidelines (14 California Code of Regulations Section 15000 et seq.) and if relevant the National Environmental Policy Act (NEPA), 42 USC Section 4-1 et. seq. and the applicable regulations thereunder; and be it further

RESOLVED, that there is no legal impediment to BAIFA making allocation requests for Regional Measure 3 funds; and be it further

RESOLVED, that there is no pending or threatened litigation which might in any way adversely affect the proposed project, or the ability of BAIFA to deliver such project; and be it further

RESOLVED, that BAIFA agrees to comply with the requirements of MTC's Transit Coordination Implementation Plan as set forth in MTC Resolution 3866; and be it further

RESOLVED, that BAIFA indemnifies and holds harmless MTC, BATA, and their Commissioners, representatives, agents, and employees from and against all claims, injury, suits, demands, liability, losses, damages, and expenses, whether direct or indirect (including any and all costs and expenses in connection therewith), incurred by reason of any act or failure to act of BAIFA, its officers, employees or agents, or subcontractors or any of them in connection with its performance of services under this allocation of RM3 funds. BAIFA agrees at its own cost, expense, and risk, to defend any and all claims, actions, suits, or other legal proceedings brought or instituted against MTC, BATA, and their Commissioners, officers, agents, and employees, or any of them, arising out of such act or omission, and to pay and satisfy any resulting judgments. In addition to any other remedy authorized by law, so much of the funding due under this

allocation of RM3 funds as shall reasonably be considered necessary by MTC may be retained until disposition has been made of any claim for damages, and be it further

RESOLVED, that, if any revenues or profits from any non-governmental use of property (or project), those revenues or profits shall be used exclusively for the public transportation services for which the project was initially approved, either for capital improvements or maintenance and operational costs, otherwise the Metropolitan Transportation Commission is entitled to a proportionate share equal to MTC's percentage participation in the projects(s); and be it further

RESOLVED, that assets purchased with RM3 funds including facilities and equipment shall be used for the public transportation uses intended, and should said facilities and equipment cease to be operated or maintained for their intended public transportation purposes for its useful life, that the Metropolitan Transportation Commission (MTC) shall be entitled to a present day value refund or credit (at MTC's option) based on MTC's share of the Fair Market Value of the said facilities and equipment at the time the public transportation uses ceased, which shall be paid back to MTC in the same proportion that Regional Measure 3 funds were originally used; and be it further

RESOLVED, that BAIFA shall post on both ends of the construction site(s) at least two signs visible to the public stating that the Project is funded with Regional Measure 3 Toll Revenues; and be it further

RESOLVED, that BAIFA authorizes its Executive Director to execute and submit an allocation request for the construction phase with MTC for Regional Measure 3 funds in the amount of \$31,276,000, for the project, purposes and amounts included in the project application attached to this resolution; and be it further



a. Project Sponsor / Co-sponsor(s) / Implementing Agency
Bay Area Infrastructure Financing Authority (BAIFA)

**b. Detailed Project Description** (include definition of deliverable segment if different from overall project/subproject)

The I-80 Express Lanes in Solano County project will construction managed lanes on westbound and eastbound I-80 to reduce public transit travel times, increase vehicle and passenger throughput, and decrease congestion. From Red Top Road to just east of Air Base Parkway, the project will convert the existing high-occupancy vehicle (HOV) lanes to express lanes. From just east of Air Base Parkway to east of I-505, the project will widen I-80 to accommodate managed lanes. The project will install static and dynamic overhead signs, electronic tolling equipment, median lighting, toll collection subsystems, electrical and communication conduits, and traffic control devices. The project will also extend an existing multiuse (Class I) trail across I-80 at Ulatis Creek. The project corridor is approximately 18 miles.

This subproject is specific to the BAIFA sponsored and implemented Toll System portion of the project. It will connect to priced managed lanes on I-80 through Alameda and Contra Costa County. It also serves as a guideway for SolTrans express bus service from Fairfield to El Cerrito del Norte

BART and enhanced express bus service from Suisun City to El Cerrito del Norte BART. Construction on this project began in 2022 and tolling is expected to start in 2025.

#### c. Impediments to Project Completion

Availability of funds is a possible impediment to project completion. MTC Resolution 4412, Revised 7/28/21 approved the LONP for the project that allowed use of exchange funds to maintain the delivery commitment of the project. The remaining amount included in this allocation request is needed to complete the toll system implementation.

**d. Risk Management** (describe risk management process for project budget and schedule, levels of contingency and how they were determined, and risk assessment tools used)

BAIFA maintains a risk register that is updated quarterly. The TransCore contract includes 10% contingency.

BAIFA is one of four Bay Area agencies that currently have the authority to operate express lanes. BAIFA will be responsible for operating and maintaining the express lanes once the project is completed.


