Contract - Regional Early Action Planning Grant: Baird + Driskell Community Planning (DBA Community Planning Collaborative) (\$525,000)

## **Subject:**

Authorization to amend a contract with Baird + Driskell Community Planning (DBA Community Planning Collaborative) to assist ABAG in implementing the Regional Early Action Planning (REAP) Grant Program 1.0 in an amount not to exceed \$525,000 for a total contract amount of \$1,925,000 for the time period as allowed in REAP Grant No. 19-REAP-13915.

## **Background:**

The state's REAP program provides time-limited funding to ABAG to assist local jurisdictions with their 6th Cycle Housing Elements and to advance local housing planning activities that accelerate housing production to meet identified needs of every community. In early 2020, ABAG applied for, and received, an initial REAP grant of \$5,900,000 and the Regional Housing Technical Assistance Program (RHTA) was launched.

After a competitive Request for Proposal process, on July 16, 2020 the ABAG Executive Board authorized the Executive Director of the Metropolitan Transportation Commission (MTC), or her designee, on behalf of the Association of Bay Area Governments, to negotiate and enter into a contract with Baird + Driskell Community Planning, currently doing business as Community Planning Collaborative (Baird + Driskell) in an amount not to exceed \$200,000 to assist ABAG in designing and implementing the REAP Grant Program through the end of December 2023. Baird + Driskell is a certified small business within the meaning of ABAG's Small Business Enterprise (SBE) Program.

With the support of Baird + Driskell, ABAG successfully applied for, and received, the balance of its REAP grant of \$18,066,861, for a total of \$23,966,861. On April 15, 2021, an amendment to add \$200,000 to Baird + Driskell's contract was approved. On November 18, 2021 an amendment to add \$500,000 to the contract was approved, with a total not to exceed \$1,050,000. On March 16, 2023 an amendment to add \$350,000 to the contract was approved, with a total not to exceed \$1.4 million.

The RHTA has been very well regarded and recently received the 2023 Award of Excellence from the American Planning Association, Northern California Chapter. The program has produced unprecedented amount of technical assistance on a wide array of housing topics; as ABAG's primary consultant, Baird + Driskell has played an integral role in developing and/or deploying these resources to the Bay Area's 109 local governments.

A broad range of additional desired technical assistance has been identified by local planning staff including support for accessory dwelling units (ADUs), understanding and implementing new state laws, and updates to local density bonus ordinances. The existing Baird + Driskell contract has been nearly fully programmed; additional funds are necessary to adequately support implementation of the newly identified technical assistance products in the remaining scope of work. Additionally, the REAP grant currently contains an expenditure deadline of December 31, 2023 – which HCD has indicated may be extended into early 2024 – and thus time is of the essence to leverage the remaining funds to benefit Bay Area jurisdictions and avoid having to return unexpended funds to the State. Accordingly, an amendment is requested in an amount not to exceed \$525,000 for a total contract amount of \$1,925,000 for the time period as allowed in REAP Grant No. 19-REAP-13915
