MTC's Community Action Resource and Empowerment (CARE) Program

## **Subject:**

MTC's CARE Program Cycle 1 Guidelines for Fiscal Year (FY) 2022-23 through FY 2025-26.

## **Background:**

MTC's CARE Program, the successor to the Lifeline Transportation Program, is a new funding program that supports transportation-based capacity building, technical assistance, and participatory budgeting for Equity Priority Communities in the nine-county Bay Area region. Administered by MTC and in coordination with County Transportation Agencies (CTAs), CARE enables community-rooted and cross-sectional partners (i.e., transit/transportation, housing, health, social services, education, etc.) to deliver on high-priority, community-level initiatives and to deepen their relationships to develop the processes, plans, and projects that will drive and sustain regional transformative transit/transportation mobility, housing, and climate action. MTC will conduct a competitive call for projects process, working with CTAs to screen and nominate CARE projects for their county. These projects are subsequently submitted to MTC for final evaluation and regional program adoption.

#### **Fund Sources**

The target programming amount for Cycle 1 is \$21.5 million, which includes four years of funding (FY2022-23 through FY 2025-26). Sources include a mix of federal One Bay Area Grant (OBAG 3) and one-time state Regional Early Action Program (REAP 2.0) funds, to support planning and capital activities: \$8 million in REAP 2.0, and \$13.5 million in OBAG Congestion Management Air Quality/Surface Transportation Program (CMAQ/STP) funds of which \$1.5M are local funds available to MTC. A minimum of \$1 million in funding for CARE from REAP 2.0 and OBAG3 will be assigned to each county for eligible projects based on a competitive process conducted by MTC and coordinated with CARE Program Liaisons in each

county. All funded projects must meet the eligibility requirements of the respective funding source.

# **CARE Cycle 1 Development**

Guidelines for CARE were developed utilizing a participatory grant making approach which includes soliciting input through a "call for project ideas" process. Results led to the identification of the grant's focus areas, estimated programming amounts, and reaffirmed the need for technical assistance, capacity building, and supporting community-based power-building and engagement initiatives. Input was also solicited from community stakeholders and partner agencies through the Transit Finance Working Group, Joint Partnership Local Streets and Roads/Programming and Delivery Working Group, County Transportation Agencies and the Policy Advisory Council Sub-Committee on Equity and Access.

#### **Guidelines**

Highlights of the proposed guidelines are summarized below.

- CARE Grant Categories. 1) Project development technical assistance for the advancement of Community Based Transportation Plan (or MTC's Coordination Plan) initiatives 2) Implementation of neighborhood-level projects/participatory budgeting; and 3) Community power-building and engagement initiatives.
- Evaluation Criteria. Overall, the proposed criteria are similar to those of the former Lifeline program, with the exception of the inclusion of REAP 2.0 requirements and "selection criteria considerations." These considerations reflect the intent to further incorporate diversity, equity, and inclusion into the project selection process.
- **Administration.** CARE Cycle 1 will be administered by MTC in coordination with county transportation agencies (CTAs).

## **Issues:**

- 1. Funds for REAP 2.0 need to be expended by June 30, 2026.
- 2. A portion of the "Power-Building and Engagement" category is being funded by \$1.5M in local funds available to MTC to benefit eligible community-based organizations (CBO); plus \$2M from REAP 2.0 for eligible recipients/initiatives. Staff is currently collaborating with community-based organizations and partner agencies to further define and measure success, refine evaluation criteria, and reduce administrative barriers for CBO involvement while incorporating accountability and outcome measures for performance. Any changes to the CARE guidelines will be brought back for Commission approval.
