Contract Amendment - Data License Extension: TomTom North America, Inc. (\$63,895.10)

Subject:

Request to authorize the Executive Director or designated representative to negotiate and enter into a sole source contract amendment with TomTom North America, Inc. in an amount not to exceed \$63,895.10 for Calendar Year 2024 to extend the GIS Base map license for an additional year.

Background:

In February 2021, the Executive Director approved a sole source 3-year contract with TomTom North America, Inc. in the amount of \$180,835.20 (\$60,278.40 annually) to provide a GIS base map for use by MTC and its partner transportation agencies. This data allows MTC staff, consultants and partners to perform complex mapping and spatial analysis for a wide variety of projects, including the Transportation Improvement Program, Regional Transportation Plan, and several on-line applications.

A sole source contract amendment is recommended because:

- MTC operates several on-line applications that utilize the TomTom GIS base map.
- MTC shares the TomTom GIS base map with several of its partner agencies such as
 VTA, AC Transit, Golden Gate Transit, and CCCTA which have begun integrating the
 GIS base map into many of their operational programs such as AVL, paratransit and
 other route planning applications. This contract amendment will provide continued,
 uninterrupted use of the GIS base map.

Contract Amendment

This memorandum requests this Committee's approval of a sole source contract amendment with TomTom North America, Inc. to extend the GIS base map license agreement for an additional year, in an amount not to exceed \$63,895.10 for Calendar Year 2024 for a new not to exceed amount of \$244,730.30.
