Consultant Contracts – Regional Mobility Hubs Planning Grant Consulting Services

Subject:

Request to authorize the Executive Director to negotiate and enter into the following consultant contracts to support the awarded Regional Mobility Hubs planning grants, to advance Plan Bay Area 2050 (PBA 2050) implementation and contribute to achieving the region's statutory 19 percent per capita greenhouse gas (GHG) emissions reduction target.

- i. Southeastern SF Mobility Hub Plan SERA Architects, Inc. (\$396,000)
- ii. Marin County Mobility Hub Plan Kimley-Horn and Associates, Inc. (\$400,000)
- iii. Antioch Park n Ride Mobility Hub Plan Fehr & Peers (\$400,000)

Background:

Mobility hubs are community anchors focused around transit stops and stations that enable travelers to access multiple transportation options – including shared scooters, bicycles and cars – all in a cohesive space, oriented to the customer. The program helps to advance PBA 2050 Environment Strategy 9, as well as MTC's Transit Oriented Communities (TOC) Policy, Active Transportation Plan and Complete Streets Policy.

In June 2023, the Commission awarded \$1,200,000 through the Regional Mobility Hubs planning grant program to San Francisco Municipal Transportation Agency (SFMTA), Transportation Authority of Marin (TAM), and Eastern Contra Costa Transit Authority (Tri-Delta Transit). The time frame for all projects will be eighteen (18) months from contract execution.

Procurement:

In May 2021, after a competitive procurement, the Administrative Committee authorized the Executive Director to establish a Bench of pre-qualified firms, to provide planning services. Twenty-eight firms are approved to be part of Regional Planning Bench Service Category 5: Transportation Policy and Implementation. After a comparative review of the Statement of Qualifications (SOQs) submitted by the firms in Service Category 5 and narrowing the list to

those with mobility hub planning experience, staff recommends a direct selection of three firms:

1) SERA Architects, Inc., 2) Kimley-Horn and Associates, Inc., and 3) Fehr & Peers.

1) Regional Mobility Hubs Planning Grants – Southeastern SF Mobility Hub Plan

SERA Architects, Inc. will provide planning services to develop SFMTA's Southeastern SF Mobility Hub Plan and assist in designing the physical improvements and service programs for communities in Southeast San Francisco to facilitate multimodal travel and alignment with the MTC Transit Oriented Communities (TOC) policy. The study will focus on Balboa Park BART, 3rd Palou/Oakdale Muni Metro Station, and the 22nd Street Caltrain Hub. SERA Architects, Inc. has relevant knowledge and qualifications to develop SFMTA's Southeastern SF Mobility Hub Plan with the following direct experience:

- Wilshire and La Cienega Mobility Hubs
- Boston Mobility GoHubs
- Arlington County Mobility Hubs Guidebook and Pilot Design Concept

2) Regional Mobility Hubs Planning Grants – Marin County Mobility Hub Plan

Kimley-Horn and Associates, Inc. will provide planning services to develop TAM's Marin County Mobility Hub Plan, and develop a coordinated, countywide approach to advance mobility hubs at rail and ferry stations in Marin County, consistent with MTC's TOC policy, at all of Marin County's TOC areas. Kimley-Horn and Associates, Inc. has relevant knowledge and qualifications to develop TAM's Marin County Mobility Hub Plan with the following direct experience:

- Contra Costa College Mobility Hub Plan

3) Regional Mobility Hubs Planning Grants – Antioch Park n Ride Mobility Hub Plan

Fehr & Peers will provide planning services to develop Tri-Delta's Antioch Park n Ride Mobility Hub Plan, and assist in the design of the Antioch Park n Ride to provide transit connections between bus, rail, microtransit, bike-/car-share and connections to a future expansion to ferry service, as well as access to electrical vehicle charging infrastructure. The Project will also analyze other Antioch locations for mobility hub potential, including TOC policy station areas. Fehr & Peers has relevant knowledge and qualifications to develop Tri-Delta's Antioch Park n Ride Mobility Hub Plan with the following direct experience:

- Bay Area Bike Share Expansion
- San Mateo TOD Pedestrian Access Plan
- Oakland Smart and Equitable Mobility Hub Pilot Program

Issues:

Staff recommends that the Committee authorize the Executive Director or his designee to negotiate and enter into the following contracts:

- 1) A contract for SFMTA's Southeastern SF Mobility Hub Plan with SERA Architects, Inc., in an amount not to exceed \$396,000.
- 2) A contract for TAM's Marin County Mobility Hub Plan with Kimley-Horn and Associates, Inc., in an amount not to exceed \$400,000.
- 3) A contract for Tri-Delta's Antioch Park n Ride Mobility Hub Plan with Fehr & Peers, in an amount not to exceed \$400,000.
