Contract Amendment – On- Call Asset Management Services: Benicia-Martinez and Carquinez Toll Bridges Asset Management Support: HDR Engineering, Inc. (\$400,000)

Subject:

A request for Committee approval to enter into a contract amendment with HDR Engineering, Inc. in an amount not to exceed \$400,000 to continue the asset management plan support services on the Benicia-Martinez and Carquinez bridges.

Background:

BATA requires a professional consulting firm to assist BATA and Caltrans staff with asset management support services on Benicia Martinez and Carquinez bridges. In May, 2022, the BATA Oversight Committee approved a contract with HDR Engineering for \$960,000 to provide initial asset management plan services for the older 1962 Benicia-Martinez and 1958 Carquinez bridge structures. In November, 2023, an amendment of \$200,000 was approved under Executive Director Authority. Work under the initial contract and amendment include funding life cycle cost analysis, preliminary fatigue analysis, risk and performing updates on existing asset management analysis on the two bridge structures and reports on other toll bridges for consistency.

This contract amendment provides additional funds to support the completion of life cycle cost analysis on the newer structures for both bridges: 2007 Benicia-Martinez and 2003 Carquinez. Efforts will include: project management support; developing life cycle cost analysis and documentation consistent with other completed analyses; quantifying risks to inform BATA's financial decision making; and assessment of all system elements for electrical, mechanical, navigation, piping and toll maintenance infrastructure and development of an inspection and maintenance plan.

Consultant Selection Process

In response to the 2022 Request for Qualifications (RFQ), staff received Statements of Qualifications (SOQs) from three consulting firms on the bench. An evaluation of the qualifications resulted in the selection of the top ranked firm HDR Engineering, Inc.
