5a. 23-0276 Contract Amendment - Credit Card Processing for the FasTrak®

Electronic Toll Collection Program: Bank of America Merchant Services

(\$56,000,000)

This item would authorize the Executive Director or designee to negotiate and enter into a contract amendment with Bank of America Merchant Services (BAMS) to 1) increase the annual contract amount to \$22,000,000 starting FY 2023 and 2) extend the contract by two-years, through June 30, 2026, in a total not to exceed amount of \$56,000,000 (see Attachment A), to continue to provide credit card processing services for the FasTrak® Electronic Toll Collection (ETC) program, subject to the approval of future BATA budgets.
